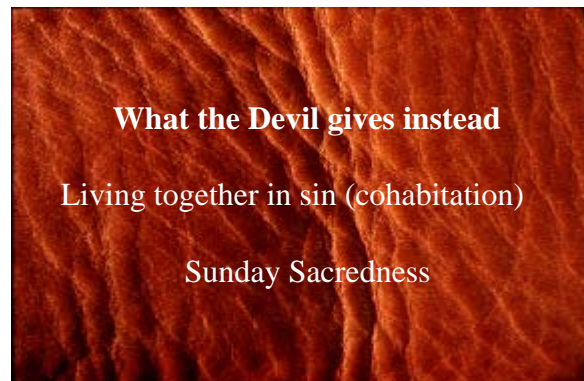
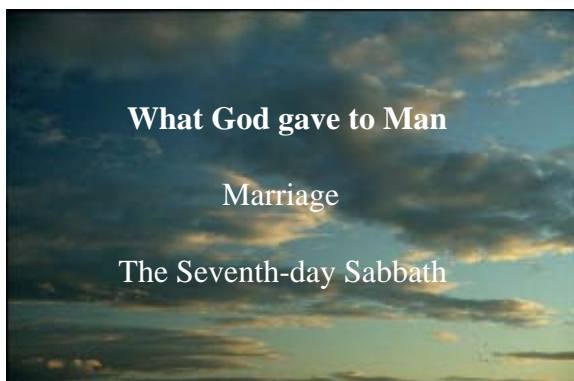

And I saw three unclean spirits like frogs *come* out of the mouth of the dragon, and out of the mouth of the beast, and out of the mouth of the false prophet.
For they are the spirits of devils, working miracles, *which* go forth unto the kings of the earth and of the whole world, to gather them to the battle of that great day of God Almighty.

Lucifer was the highest angel in heaven. He was a created being, and was next in line to CHRIST in power, rank and authority. When the GODHEAD came together to discuss the administration of the universe, he was not permitted to enter into their secrets, and for this reason he developed a hatred for God and disrespect towards His law, because God's government rests on the foundation of His law. It is through his influence today that there is a large movement in the religious world who believe it is no longer expedient to keep God's law. It should be remembered that Lucifer's position in heaven was the Covering Cherub (the chief angel). He stood in the immediate presence of God's glory and was clothed with a garment of light. It is also important to

remember that Lucifer means "light bearer." All his power and wisdom came directly from the most High; but this he attributed to himself, instead of from Him who is the giver of all knowledge, wisdom and power. In the heart of this arch-deceiver was the desire to put himself in the place of God, and this marked the beginning of the great controversy, which is about to reach its climatic end very soon. This ancient foe who received his education from Jesus at the throne of the living God, is attempting to use the administrative skills that he learned whilst being God's messenger. At this time, Satan's methods of operation parallel the same basic principles as the Lord's - but they lack the foundation of God's Ten Commandment Law.



Frogl like movements



God in His mercy to the human race has given the three angel's message as a means to prepare us for the world to come. Satan in response to this has three unclean spirits like frogs. Both of these movements end up on seas. The three angel's message ends up on the sea of glass that flows by the throne of God.¹ While the three unclean spirits like frogs culminate in the lake of fire.² One produces obedience to the law of God; while the other prepares humanity to worship the beast and his image. This issue is to be clearly understood by all who dwell on the earth at the end of time. God's message to come out of Babylon is given under the direction of the Holy Spirit. False calls of unity, however, are given under the auspices of evil angels. These spirits are described as being like frogs. According to the Biblical record, during the ten plagues that fell upon Egypt, (which were a type of God's final wrath) there was a plague of frogs. It is a fact that the frog was regarded as sacred by the Egyptians, and they would not destroy them³, for one of their gods, HEGA, was a frog headed goddess, thought to possess creative power. So as these movements go forth unto the inhabitants of the earth, they will be considered sacred and untouchable. They will be revered in the same manner as were the frogs of ancient Egypt. Only those who have a deep and personal relationship with Christ will dare speak a word of protest against them. **THEY COME OUT OF THE MOUTH** of the Dragon, Beast and the False prophet. As God's three angel's message is to be preached, these Satanic movements are to be proclaimed verbally as well as spiritually, and intellectually. So we can positively say they are **Satan's evangelistic tools for world domination**.

WHO OR WHAT IS THE DRAGON?

According to Revelation 12:9 the dragon is that old serpent called the Devil and Satan, him who deceived the whole world. So the dragon power is raw Luciferianism, which has its ideology rooted in Satan's lies to Adam and Eve in the Garden of Eden. There are three fundamental principles that need to be understood in the fall of man, in the third chapter of Genesis.

(1) "Yea hath God said" Genesis 3:1.

This dragon power is playing a fundamental role in placing doubt upon God's word, and we are witnessing the fruits of decades of the dragon's attack. There are two major beliefs in the world today that are at the forefront. The first is **Evolution**. This teaches that there was a "big bang", and that all life on earth developed over millions of years. Evolution refutes the Biblical account of creation, as recorded in Genesis Chapters 1 and 2. The Bible declares that the world was created in six days, and that God rested on the seventh day. The seventh day was blessed and sanctified because it was always to be a memorial of the creative power of God. The second belief is **Higher Criticism**. Higher criticism is a method that places doubt on the authorship, origin, and historical settings of Biblical themes and places. Its purpose is to make the Bible seem as though it is a book full of nonsense - the end result being the scriptures are totally disregarded as being inspired by God. "If a supposed conflict is found between the theories of science and the facts of the Bible, the scholar is expected to reject the Bible. In actuality, there is no conflict between true science and the Bible, but this fact did not deter the higher critics."⁴ Higher criticism is being taught in many of the schools, colleges and seminaries around the globe, and it is sad to say that because of this, many religious teachers and preachers are closet atheists.

(2) The second principle is based on Genesis 3:4: "ye shall not surely die."

These words are the foundation of modern spiritualism; and are also the first ever sermon

preached upon the immortality of the soul. This declaration, resting solely upon the authority of Satan, is echoed from the pulpits of Christendom, and is received by the majority of mankind as readily as our first parents. Not only is it declared by churchmen, but billions in this passive, sophisticated TV generation, also accept this satanic lie. The majority of films that come out of the entertainment industry advocate the view of immediate life after death. God's word tells us in **Ezekiel 18:20**: "The soul that sinneth it shall die." The doctrine of natural immortality first borrowed from pagan philosophy, and in the darkness of the great apostasy incorporated into Christian faith, has supplanted the truth so plainly taught in scripture, that *the dead know not anything*.⁵

(3) The last principle of this global deception is found in Genesis 3:5: "**Ye shall be as gods.**"

This concept is fundamental in all pagan religions, with the belief that we have the capacity to produce righteousness within ourselves. But the word of God says you must be born again. If we were to look for the fulfilment of this prophecy, we would have to look no further than what modern spiritualism teaches: "that man is the creature of progression; that it is his destiny from his birth to progress, even to eternity, toward the godhead."⁶ As we see the movements taking place in the world, with the amalgamation of worldly music in the church worship service, and the proclamation of the sin and live gospel, there is also the acceptance of self-esteem, i.e. "you can do it."

The Interfaith Movement, which has its headquarters in the World Council of Churches in Geneva, is the main tool that Satan is using to destroy Biblical Christianity. Its President since 1975, Cynthia Wedel, is an honorary sponsor of the Provisional World Parliament. "This organisation has come to represent the leadership of most of the mainline Protestant church denominations in America and has privately been pushing for unification with the Church of Rome. But it appears that the WCC is only trying to "unite" Christianity in order to bring it into the New World Order."⁷ As the WCC is one of the driving forces of the coming

reign of terror, and is part of Satan's Grand Master Plan to establish a World Community, **we need to embrace the truths of the Bible and the Bible only**. The mass exodus of believers taking place in the Christian Church, we are convinced, is due to the dragon power. The principles of evolution, higher criticism and spiritualism are being accepted by almost all major denominations. As a result church members who embrace the above principles do not know whether they are coming or going, or what they believe. The result being that such individuals will not be able to stand in the coming world crisis.

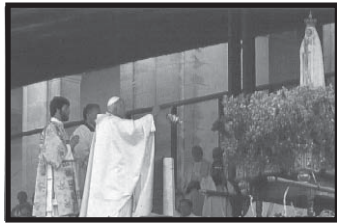
OUT OF THE MOUTH OF THE BEAST



It is a fundamental truth of historic Protestantism that the beast in Revelation 13 and 17 is the **ROMAN CATHOLIC POLITICAL MACHINE [THE VATICAN POLITICAL TEMPORAL GOVERNMENT]**. This was established during the dark ages. All the Reformers held this conviction from the study of the scriptures and history. It was only during the counter reformation that the Jesuits, Francisco Ribera (1537-1591), Robert Bellarmine (1542-1621) and Luis De Alcazar (1554-1613)⁸, devised the doctrine of a futuristic antichrist. They achieved this by putting the time prophecies pertaining the antichrist into the future. They also destroyed the principle given in Numbers 14:34 and Ezekiel 4:6, which shows that a day stands for a year in Bible prophecy. The Jesuits altered this by teaching that these were literal instead of prophetic days.

This means that the one thousand two hundred and sixty days (**Revelation 12**), and the forty two months (**Revelation 13**), will be fulfilled at the

end of time instead of the historical view that this time frame refers to the dark ages, when the papal power controlled the world from 538 A.D. -1798 A.D. This beast power is to emerge at the end of time to become the world's leading super power. "And his deadly wound was healed: and all the world wondered after the beast."⁹ Pope John Paul II believes that the Virgin Mary will crown him the spiritual and temporal king of a NEW WORLD ORDER by the year 2000.



Religious orders

There are many lay and religious orders in Rome and around the world who are devoted to see this goal established, groups like Opus Dei, Legion of Mary, Focolare, Neocatechumenate, and Communion & Liberation, The Knights of Malta, and P2, who are the papacy's own Lodge. There are many more such societies around the globe under the direction of the Pope, infiltrating every aspect of human life. The diabolical aim of this Papal Global Octopus is to create a Christian society which has been extinct since the middle ages; a restored version of the Holy Roman Empire.¹⁰

Rome is behind every subversive movement directly or indirectly. This is done by her agents who penetrate and infiltrate any and every movement that are striving for world domination. The church of Rome claims to be an institution under the control of God.

It also feels that it has the keys to the kingdom, but a careful investigation will prove that it's roots derive from ancient Babylon [**Revelation 17:5: MYSTERY, BABYLON THE GREAT, THE MOTHER OF HARLOTS AND ABOMINATIONS OF THE EARTH**]. This name is written on her forehead. The occultist and neo-Gnostics of today are only too well aware that the worship of Mary by the Roman Catholic Church is directly linked with the goddess cult of the ancient Babylonians.¹¹

Environmental worship

Mary is also the base of the Environmental Movement: for they teach that the earth is a goddess or the Great Ghea. Environmental goddess worship leads to witchcraft. Every liturgical format of Catholicism can be traced to ancient Babylon:

"The use of temples ... incense, lamps and candles ... the tonsure ... turning to the East, are all of pagan origin, and sanctified by their adoption in the church."¹² Popery boasts of being the "old religion; and truly, ... it appears that it is ancient indeed. It can trace its lineage far beyond the era of Christianity, back over 4000 years ... to the Tower of Babel.¹³ It is our responsibility to give the trumpet a certain sound and warn the world of the nature, the history, and the present position of **Rome**, for **she is what inspires the dragon and the false prophet**.

OUT OF THE MOUTH OF THE FALSE PROPHET



In the book of Revelation we are shown the Bible definition of the **false prophet** and the work that this power will do. Revelation 13:11-14; 16:13-14 and 19:20 reveal that the **lamb-like beast** and the **false prophet** is the **same power**. It is prophesied to work miracles, to bring down fire from heaven to deceive those that dwell on the earth. Whilst the true prophet of God, Elijah, brought down fire from heaven as a sign of the worship of the true God (see 1 Kings 18), the false prophet, or the lamb-like beast (the **USA**), will bring down fire from heaven as a sign to lead

people into false worship. But the Bible says: “If there arise among you a prophet, or a dreamer of dreams, and giveth thee a sign or a wonder, And the sign or the wonder come to pass, whereof he spake unto thee, saying, Let us go after other gods, which thou hast not known, and let us serve them; Thou shalt not hearken unto the words of that prophet, or that dreamer of dreams: for the LORD your God proveth you, to know whether ye love the LORD your God with all your heart and with all your soul.”¹⁴

The Christian Coalition

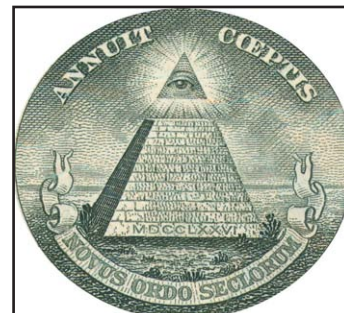
There is in the USA a group of men who are pushing for America to become a nation controlled by the church. They call their establishment the Christian Coalition. Their leader is Ralph Read. They would like to introduce a national Sunday law, and their aim is to penetrate the government by having political candidates run in elections. The C.C. (Christian Coalition) want to take the world to how it was during the days of ancient Israel, when the people of God were under the jurisdiction of a THEOCRACY.¹⁵ This means that the EXECUTIVE¹⁶, LEGISLATIVE¹⁷, and JUDICIAL¹⁸ government derives its power immediately from God. They plan to accomplish this by laying a grass roots resurgence of Christian action, where local church members elect those in office of state to do the bidding of the Church.

They also believe it is their duty to restore all the old civil laws of the Old Testament, and the penalties for breaking them. The C.C. was represented at the last presidential election (1996) by senator Bob Dole and the Republican party. We are living at the very end of time, and the final, rapid movements, are taking place.

Ellen White, who wrote in 1888, was guided by the Holy Spirit when she declared: “When the leading churches of the United States, uniting upon such points of doctrine as are held by them in common, shall influence the state to enforce their decrees and to sustain their institutions, then **Protestant America will have formed an image of the Roman hierarchy**, and the infliction of civil penalties upon dissenters will inevitably result.”¹⁹

★ Conclusion ★

The effects of this threefold union will be the destruction of morality in the Church and the World. We are seeing the amalgamation of Christianity with the polytheistic religions of the East, and there is a breakdown in the whole construction of society. Spiritualism, Catholicism and Apostate Protestantism are clasp hands in an unprecedented fashion, and slowly but shortly, gathering the world to the valley of slaughter [Ar-Megeddon] (**Revelation 16:16**). This slaughter will result in the complete and eternal destruction of those who go along with Satan’s system. GREAT BRITAIN - THE BATTLE AXE OF PROTESTANTISM

The Act of Union

It was at the very time of the Papal scheme to overthrow the English people that this nation was to arise to dominate the world for over a hundred years. In the year 1603, upon the accession of James VI of Scotland, who was also known as James I of England, the two crowns of the two countries were permanently joined together. This sowed the seeds of a union that was to bring two ancient people to a long standing partnership, to the point that when England went to war Scotland did also. In the troublesome times of 1707, at the death of Queen Anne, the Roman Catholic led Scottish JACOBITES threatened to put an exiled Stuart on the throne. **The birth of the Empire was established by the signing of the ACT OF UNION, which was designated to protect these grand nations from Popery.** The Scottish Parliament and Privy Council were then absorbed by those of GREAT BRITAIN [England, Scotland, Ireland and Wales]. LONDON was to be the main centre of the union. Out of this alliance against the infringements and abuses of popery came a

united kingdom, that was to lead the way in the struggle for civil and religious liberty: It is said “the sun never sets on the BRITISH EMPIRE.” At this point it would be pertinent to give a brief synopsis on how this nation came to be one of the world's leading superpowers.

The English people took a peculiar stand against the infringements and the abuses of tyranny that were the trademark of medieval EUROPE. We have touched on the year 1707 A.D. as the date of the coming of the U.K., but the implementation of liberty and most important instrument of English constitutional history, was issued by King John in June 1215 A.D. at Runnymede “The MAGNA CHARTA (commonly called the MAGNA CARTA).”

John's turmoil

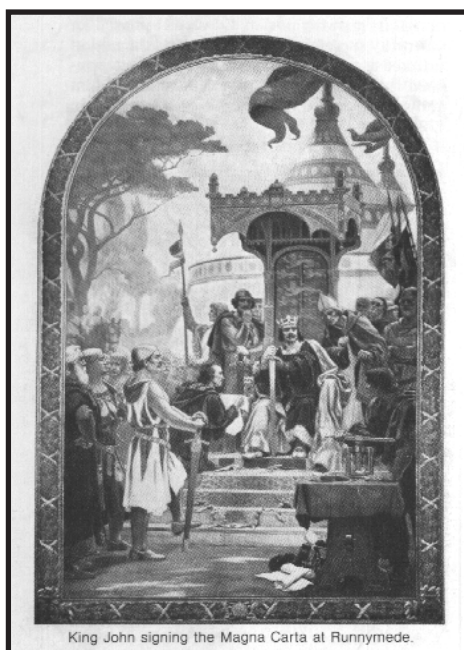
Under the compulsion of the barons, John was forced to sign this document, because of his continual extortion of money, and his violations of feudal rights. He not only fell into disfavour with the nobles but also with the knights and with the townspeople. John also quarrelled with Pope Innocent III over who would be archbishop of

Canterbury. In 1208, Innocent put England under an interdict, cutting off the entire land from the services and sacraments of the church. John retaliated by confiscating the property of the archbishop of Canterbury. In 1209, the pope excommunicated John and offered the crown of England to King Philip II of France. Philip and a mighty army prepared to cross the English Channel and take England away from its excommunicated King.

It seemed that John was trapped. He knew he could not count on the nobles for help. They hated him for his lack of respect for the feudal promises between lord and vassal. To escape the English nobles on the one side, and the French warriors on the other, John ran to his third enemy, the Pope. He repented of his deeds, restored the church property, and then, to the horror of all Englishmen, he offered England to the pope as a fief of the papacy. "Here I resign the crown of the realm of England into the Pope's hand, Innocent III," he said, "and put me wholly in his mercy and ordinance." John's cowardly deeds aroused the patriotism of the nation. The great English nobles, called barons, vowed that they would never be slaves of a pope. Even the English clergy now felt that the Roman pope had too much power over the English church because of the alliance with John.¹

The MAGNA CARTA (1213-1215) was seen as the first bill of rights, for it was the guarantee of the supremacy of the individual over the King. It also provided for the freedom of the church. Most important it was later to be interpreted as a guarantee of trial by jury and of Habeas Corpus [the right of the family to see the body of the detained prisoner]. It can be said to be the foundation of religious and civil liberty. King John was released from its observance by the Pope.² It can be right for us to say that because of this document's approach to freedom, it was hated by the Papacy, for it was in direct opposition to the principles of the inquisition that were developing in Europe at that time, if we take a historical sweep into Rome's aggression on this nation. In 1066 A.D. the military subjugation started when William the Conqueror secured the sanction of the Pope, to raise an army and fleet. He defeated and slew King Harold in the Battle of Hastings. Overcoming what little resistance that remained in Kent, he made his way to London, received the city's submission, and was crowned King on Christmas day.³ We would like to remind the reader that never since that time nine-hundred and thirty one years ago, has a Papal sponsored army put its foot on the mainland of England. God's omnipotent providence has kept us free from the "Vatican's invasion forces for nearly a thousand years."

The signing of the Magna Carta

A DIFFERENT RELIGION FOR THE BRITISH PEOPLE



In Great Britain primitive Christianity had very early taken root. The gospel received by the Britons in the first centuries was then uncorrupted by Romish apostasy. Persecution from pagan emperors, which extended even to these far-off shores, was the only gift that the first churches of Britain received from Rome.⁴

One Papal leader said "If you will not receive brethren who bring you peace, you shall receive enemies who will bring you war. If you will not unite with us in showing the Saxons the way of life, you shall receive from them the stroke of death."⁵

Early missionaries in England

In the early centuries, the church in England took on a distinct character - it was a centre of missionary activity, with men like Columba, Patrick, and Aidan. These men of God were fundamental in pioneering schools, colleges, and centres of training for young people. The school at Iona sent missionaries, to Scotland, England, Germany, Switzerland, and even Italy.

The Word of God nurtured the moral fabric of the people, and released an independence not possessed by the rest of the continent. It will also be good to mention that these early heroes were **seventh-day (Saturday) Sabbath keepers**. It is fascinating to see how ROME, claims these men of God to herself. As the Holy Spirit influenced them in their work the great formation of liberty trickled down through society, for where the Spirit of the Lord is, there is liberty.⁶

A HISTORICAL SKETCH OF THE PAPACY'S WAR WITH BRITAIN

1) **1066 A.D.** The battle of Hastings

3) In **1533** Henry's adviser Thomas Cranmer became Archbishop of Canterbury. In **1534** Parliament abolished the Pope's [Clement VII] authority in England and declared King Henry VIII, the supreme head of the Church of England [The Act of Supremacy]. "The English clergy and Parliament recognised Henry as "the supreme head of the English Church, and the pope's name was erased from books in the English churches. Henry closed the English monasteries and commissioned the printing of English Bibles so that every church in the country have one."⁷

4) **1553 A.D.** Mary I [Mary Tudor, or Mary the Catholic] ascends to the throne of England. At the time of Henry VIII's death, his son Edward VI turned England into a Protestant nation, but he died at a young age. For several days Lady Jane Gray usurped the throne. But the people

requested that Mary should become Queen of England. In the second year of her reign, she allied England with Spain, and married prince Philip, who was the champion of Catholicism.



The result of this union was a rebellion by the Protestants, led by Lady Jane Gray and Elizabeth. When Mary first took the throne she promised the people she would not revert back to Catholicism. But this promise she broke. In 1555, Mary began persecution of the Protestants in England, which earned her the name of "BLOODY MARY." At the time of her death in 1558 almost 300 men and women had been burned at the stake because they refused to return to the Catholic Church.⁸

5) **1558 A.D.** On November 17, Elizabeth, the daughter of Henry VIII and Ann Boleyn, became the Queen of England. ELIZABETH I, because of her love for the Protestant religion, was marked for assassination by the Vatican. By the year 1570, on February 25th, she was excommunicated by a bull from Pope Pius V, in which he declared her "to be cut off as the monster of iniquity from the community of the faithful."⁹ He released her subjects from their allegiance to her, and he forbade them, under pain of incurring the same sentence as herself, to recognise her any longer as sovereign ... nor did he refuse his blessing, with money now and a high place in heaven hereafter, to any assassin who would undertake to sheath his dagger in her breast.¹⁰ Because the Catholic Church desperately wanted to recapture England, there was plot after plot to destroy

Queen Elizabeth I and put a Romanist on the throne.

The Babington Plot

The final straw was when Elizabeth's cousin Mary Stuart (not Bloody Mary), was uncovered to be part of a conspiracy called the Babington Plot. This plot was to put Mary on the throne. Mary was convicted of treason, and with reluctance Elizabeth signed the death warrant of her cousin. "When asked to convert to Protestantism Mary replied: "I am a Catholic, and must die a Catholic. It is useless to attempt to move me and your prayers will avail me but little." Fearlessly, she stepped to the block and was beheaded.

This was the last attempt by Rome to find a solution from within the nation. All prospects of the English Romanist dealing with the Protestants of England were terminated with the axe of the executioner. From henceforth the Papacy looked to their champion nation and defender of faith - SPAIN.

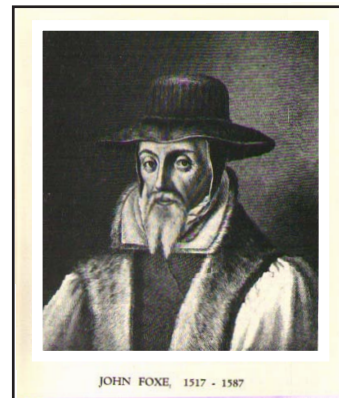


Elizabeth's cousin - Mary Stuart

JOHN FOXE

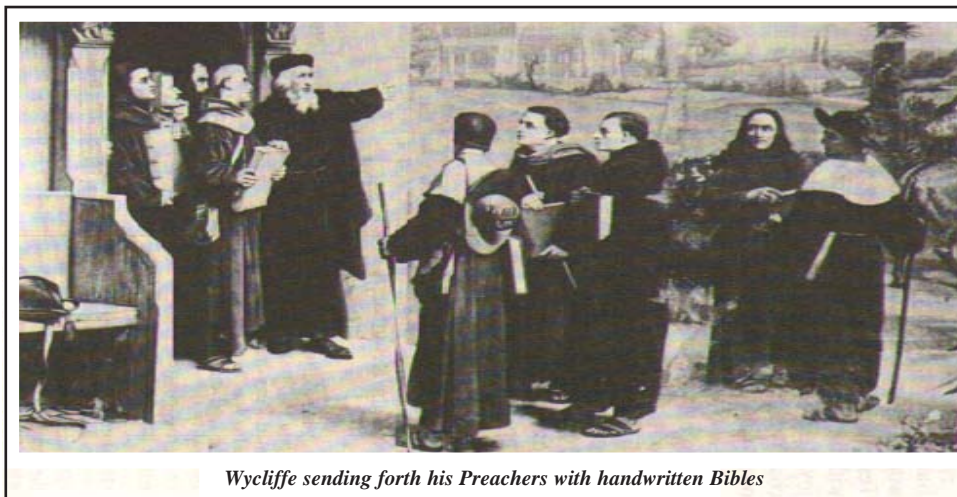
(1517-87)

Nonconformist preacher, author, and visionary, was born in Boston, in Lincolnshire, one hundred miles north of London. His chief claim to fame rests on his *Acts and Monuments*, a history of the Reformation popularly called *The Book of Martyrs*, which is unexcelled as religious propaganda. It went through many editions and was placed alongside the Great Bible in every college hall, university, and parish church in England to become the most popular reading of the day and for centuries after. Foxe was noted for his charitableness, tolerance, and his opposition to the wearing of surplice. He died in London.

WILLIAM TYNDALE

(ca. 1483-1536)

Reformer and linguist, was born in England on the Welsh border. His translation of the Scriptures into the English tongue placed him among the renowned in scholarship and literary ability. Because of religious persecution in England, he went to the Continent. As a guide to his work he used the translations of Luther and Erasmus. His Bible became the basis for the Authorised Version and served as the fulcrum on which the English Reformation balanced. He was captured and imprisoned on the charge of advocating justification by faith, opposing the doctrines of purgatory and the invocation of saints, and was executed by strangulation and burning near the castle of Vilvorde, in the Netherlands.

JOHN WYCLIFFE (ca. 1320-84), authority on canon and civil law, consultant to Parliament, king's chaplain, Reformer, and founder of the Lollards, was born in Yorkshire, England. He based his first opposition to the papacy on its political activities. To Parliament he recommended that the fines assessed by the pope against the realm under King John be abrogated. Later he attacked the doctrine of transubstantiation and the ecclesiastical supremacy claimed by the pope. He affirmed his belief in salvation by faith. His translation of the Bible gained him literary prominence. Papal pressure expelled him from his university position, but was unable to effect his excommunication. He died of a paralytic stroke in his parish at Lutterworth, England.

GOD BLEW WITH HIS WIND AND THEY WHERE SCATTERED

When in July 1588, during the reign of Queen Elizabeth I, the Roman Catholic Church ... attempted the conquest of England, she came with a fleet of one hundred Spanish galleons, carrying thirty thousand fighting men ... It will be remembered that years before the Armada weighed anchor in the Tagus on its ill-starred mission, England was overrun by continental Jesuits, priests, monks, and sisters. The "seminary priests" from Rheims were a notorious contingent of that army. These were strategically arranged and placed, that their influence was made to be felt everywhere. They were in the court of Queen Elizabeth I, they were in the castles of the nobles, in the houses of the

wealthy, and even in the cottages of the poor. Jesuits wormed their way into society, going from house to house ... in pairs like black cats, as Dickens has told he saw them do in Genoa. They were surveying, examining, reconnoitring with a view to an open conquest ... in a subtle ... almost unseen way, undermining the commonwealth, and making or attempting to make, a conquest of England.¹¹

The Papal plan for England

The Papal plan for England was to erect the inquisition, and force the British people to accept the primacy of the Pope. On board this papal fleet were 180 Dominican and Franciscan friars and monks, with instruments of torture like the thumb screw and rack. While on the mainland, the military machine of Rome was gathering information of all the enemies of the Catholic Church, starting from the Queen right to the bottom of the social ladder; a compilation was made of persons to receive extermination. The Jesuits also worked on breaking down the defence systems of the nation, by forbidding any Catholic in the armed forces on the pain of excommunication, from swearing allegiance to the Queen. The invincible Armada, was perhaps the greatest naval force the world had seen. The plan was for the Armada to sail up the Channel, pick troops from the Netherlands, and invade and conquer England. Although the English fleet was smaller, it was better designed than that of Spain. The Armada missed a golden opportunity to trap the English fleet in Plymouth harbour on July 19 and 20. After ten days of fighting, the British fleet completely defeated the Spanish ships. As

the remaining Spanish ships sought to escape by sailing northward around the British Isles, a terrible tempest arose - "The breath of God, or the Protestant whirlwind as it is called."

The power of God

Many of Spain's fleeing ships were dashed to pieces on the shores of Scotland and Ireland. If Spain had succeeded, the whole subsequent history of England and Scotland would have been changed; there would have been no Protestant North America, and no Anglo-Saxon civilisation.¹² The present author is of the conviction that God Himself was fighting for His people, like in the days of Moses, Gideon, and King David. It is a fundamental principle that God's protection is only given to people and nations that are loyal and God-fearing, and at that time ENGLAND was experiencing the regenerating power of the Gospel, and the acceptance of Protestantism was shaping government, judicory, and individual faith in the Lord. This explosion of 'sola scriptura' (the Bible and the Bible only), elevated the British Isles to military and commercial greatness, with an unchallenged position as the world's

superpower for over 200 years. The word of God declares: "**Righteousness exalteth a nation: but sin is a reproach to any people.**" (Proverbs 14:34). We desperately need, in this solemn time in which we live, to have the old-time religion, and the Christian principles of our spiritual ancestors, for it was Bible religion that made this land the great nation that it was in the past, and only the same principles can achieve matching results today; not only for the nation, but also for individuals. We are coming to the point in this world's history where God will not only be dealing with nations, but He will be looking for people who have made a covenant with Him. This covenant is to be made by the heart being surrendered to the Lord in absolute submission to His word, and through moment by moment, unbroken communion, with Jesus Christ our Great High Priest.

A reformation needed

After the life and death struggles with Spain, and the hard fought battle to save the English people ... Protestantism took stock of its situation and organised for the new era which had evidently dawned. A thousand ministers, it is said, sent a petition, called the Millenary Petition, to King James who had succeeded Elizabeth as sovereign.¹ This petition called for reformation in the ministry and worship of the national church. Among other things, Doctor Reynolds who was a chief speaker on their behalf, the leader of the Millenary Petition, requested that there might be a new translation of the Bible, without note or comment.

Unsurpassed scholarship

The first three hundred years of the Reformation produced a grand array of scholars, who have never since been surpassed ... It was said of one of the translators of the King James that “such was his skill in all languages, especially the oriental, that had he been present at the confusion of tongues at Babel, he might have served as interpreter general.”² No-one can study the lives of those men who gave us the King James Bible without being impressed with their profound and varied learning. Furthermore, in the book *Modern Bible Translations unmasked*, Dr. R. Standish and Dr. C. D. Standish have documented quite comprehensively the highly advanced scholarship of just a few of the translators.³ The translators of the King James, moreover, had something beyond great scholarship and unusual skill. **They had gone through a period of great suffering. They had offered their lives that the truths which they loved might live.**

Satan tries to intervene

“King James responded to the call. He appointed fifty-four learned men, all with a reverent regard for divine inspiration to bring into being a Bible that would reflect the greatest possible concern to achieve fidelity of translation. By the time the work begun, the number of translators had been reduced by circumstance and death to forty seven.”⁴ *This was because some of the translators and their families were poisoned by Jesuits.*⁵ The forty-seven learned men appointed by King James to accomplish this important task were divided first into three companies: one worked at Cambridge, another at Oxford, and the third at Westminster. Each of these companies again split up into two. Thus there were six companies working on six allotted portions of the Hebrew and Greek Bibles.

High security



The importance of the King James Version was so great, that guards were posted at the tables of the translators, watching every move, as a precautionary measure to stop any possible Jesuit infiltration during the translation process.

Each member of each company worked individually on his task, then brought to each member of his committee the work he had accomplished. The committee all together went over that portion of the work translated. Thus, when one company had come together, and had agreed on what should stand, after having compared their work, as soon as they had completed any one of the sacred books, they sent it to each of the other companies to be critically reviewed. If a latter company, upon receiving the book, found anything doubtful or unsatisfactory, they noted such places, with their reasons, and sent it back to the company whence it came. If there should be a disagreement, the matter was finally arranged at a general meeting of the chief persons of all the companies at the end of the work. It can be seen by this method that each part of the work was carefully gone over at least fourteen times.

In the multitude of counsel there was safety

It was further understood that if there was any special difficulty or obscurity, **all the learned men of the land could be called upon by letter for their judgement.** And finally each bishop kept the clergy of his diocese notified concerning the progress of the work, so that if anyone felt constrained to send any particular observation he was notified to do so.⁶ What a contrast to the way most modern translations of the Bible are prepared. Never since that time from 1604-1611 has there been such dedication, commitment, and consecration in preparing a Bible in the English language for the common people. That is why today, at the end of this century, almost four hundred years later, many Protestants still use the King James Version in recognition of its outstanding accuracy.

It is a fundamental feature of the struggle that developed during the Dark Ages, between Roman Catholicism and Protestantism, that the choice of manuscript (MSS) determined the system of belief. It can be traced through history that there are only two text families: one which originated from the apostles, given to their converts, hence called the Received Text, for it was received by the people who were converted. And the other, the corrupt Alexandrian MSS,

which became the Sinaiticus and the Vaticanus. The manuscripts here mentioned, because of the hatred of the Gnostics to Jesus, were severely mutilated. That is why in all the modern and ancient Catholic translations there are hundreds of omissions. These corrupt manuscripts, which were tampered with by the Gnostics, who did not believe the plain gospel of Jesus, became the foundation of Roman Catholic Bibles. It would be an injustice to try and cover this topic in such a short space, but the reader can refer to Modern Bible Translations *Unmasked*, available through this ministry.

The acceptance of the Textus Receptus (the Received Text) shaped the democratic process of government in this country. It also provided for the manner in which the armed forces were to treat their prisoners of war. Society was built on charity and men began to care more for each other. The courts abandoned Roman Catholic

Canon Law and practised trial by jury and a fair penal system. Britain, and the Protestant American Republic which was formed on the basis of Christianity, were developed into safe havens: all as a consequence of the Bible from the pure manuscripts being translated into the language of the people. But unfortunately Rome never tolerates such freedom to worship, and

soon planned a event that was to be a monument for the 5th of November- the **GUNPOWDER PLOT**.

GUY FAWKES THE MAN

Born in 1570 in York England, during the reign of Queen Elizabeth I, is a man who's name has left a legacy that has lasted for almost four hundred years. He was born into a Protestant family, but at the age of eight suffered the loss of his father. His mother remarried a man named Baynbridge of Scotton, who being a member of the Roman Catholic faith, introduced and persuaded him to become a Romanist. At the coming of age, showing much valour and zeal for the Catholic cause, he left Yorkshire for the continent to be a soldier in the Spanish army. In 1604 he was asked by Robert Catesby to come back to England, to assist in the plot to blow up the King and his parliament, to restore Roman Catholicism on the throne of England. We are

talking about none other than Guy Fawkes, sometimes called Guido, for that was the name he signed his confession with. But we will call him 'Guy' because that is what he is called in the official account of his trial.

A new hope for the Catholic Church

At the death of Queen Elizabeth I, the Roman Catholics in England looked to a brighter future. They saw that at the removal of the 'Virgin Queen' they might obtain more liberties for the practice of their faith. Elizabeth's reign was marked with heavy persecution's and fines, because of the activities of the Jesuit faction and their followers in England. They saw in King James I, whom was the heir of Mary Stuart, better known as 'Mary Queen of Scots', the

re-establishment of their religion as the sole religion of the state. But as time went on, they realised that many of the promises that King James made to them were not kept. Instead of liberty and freedom, their burdens were to increase.

The Secret Service



Robert Cecil, the Earl of Salisbury and Secretary of State, was the key figure in tracking the plots and conspiracies of the Roman Catholic terrorists that were active in mainland England. **It could be said that he was the founding father of the modern secret service, for he employed his spies to keep a close watch on all the movements of the Jesuits in England.** This was achieved by Cecil's men infiltrating the ranks of the fanatical men who were bent on the destruction of our Protestant throne and Constitution. It is said that he had knowledge of what was going on at least three months before that diabolical day on the fifth of November, a day that is commemorated with fireworks and merriment.

THE PLAN

The name Guy Fawkes throughout the centuries has been linked with this diabolical plot. But in reality, he was just a pawn to be used as a smokescreen for the real personality and mastermind of the scheme, to overthrow the crown and the government. The principle plotter in the Gunpowder Treason was **Robert Catesby**. By the influence of his restless brain, Guy Fawkes fell into subordination.

Born at Lapworth, Warwickshire, in the year 1573, Catesby was the only surviving son of William Catesby by his wife Ann, a daughter of Sir Robert Throckmorton. He was lineally descended from the famous counsellor (William Catesby) of King Richard III ... 'Mr Catesby,' says Father Gerard ... was a gentleman of an ancient and great family in England.¹ Robert Catesby was in his time respected by the highest members of society. He was also a practising Catholic and a staunch supporter of the Jesuit faction. It was Robert Catesby that was to recruit the rest of the conspirators.

The following is a list of their names: Guy Fawkes, Thomas Percy, Thomas Winter and Robert Winter, Sir Everard Digby and Francis Tresham, John Wright and Christopher Wright, Thomas Bates, Father Henry Garnet S.J. (Jesuit), Robert Keyes, Ambrose Rookwood and Father Oldcorne S.J.

Men of wealth

It is interesting to note that the majority of these treacherous men came from the aristocracy. They were not though common thugs, for they were men of learning and great wealth. If they were to be alive today, many of them would be millionaires. Although November 5th is remembered for the attempted destruction of parliament, the plan of the Jesuit faction of the Catholic Church was much wider than people think. Philip Sidney in his book 'A History of the Gunpowder Plot' paints a graphic picture of their overall aims:

1. To blow up the King, Queen, Prince of Wales, Lords and Commons, at Westminster, by means of the mine to be fired by Guy Fawkes.

2. An attempt to capture the Duke of York (Prince Charles, afterwards Charles I).
3. An insurrection in the Midlands; the meeting-place to be Dunsmoor Heath, whence Digby and his friends were to proceed to Lord Harrington's house, Combe Abbey, near Coventry, there
4. To seize the persons of the little Princess Elizabeth (afterwards Queen of Bohemia), who, in the event of Prince Charles remaining untaken, was to be proclaimed Queen.
5. To seize the person of the baby Princess Mary.

Bravery or madness?

To have the mind to do such a thing against royalty at that time was unimaginable, for it was sure to mean certain death for anyone caught stealing a handkerchief, let alone to capture the rulers of the land. Thus we can see the lengths that those involved in Romanism will go to, to further their aims through the deceptive power of the devil. It is fascinating when one realises that had they achieved their goals, the whole picture of English, European, and world history, would have been totally different. For this nation would have sank into the abyss of darkness both intellectually and spiritually. It is right to say that there would have been no Commonwealth and American Republic. The King James Bible would also have been non-existent, which was at that time one year in the process of being translated into the English tongue.

FOUR REASONS FOR THE PLOT

1st Reason:- King James was raised a Protestant, and was always a Protestant at heart. It is a known fact that he authored staunch Protestant literature. At the age of twenty he wrote a book called "A Paraphrase upon the book of Revelation of the Apostle St. John." In this book he identified the Roman Catholic Church as the Anti-Christ of the Apocalypse. He used Revelation 13, 17, and 18 as his key scriptures to identify the Papal system.

2nd Reason:- King James had led the Catholics to believe:

- a) That he would offer religious tolerance (Religious freedom to all Catholics).
- b) Rumours were also spreading that James himself was to become a Catholic, and his son the future heir, was to be brought up in Rome, therefore ensuring a Romanist occupying the throne of England as its future King.

3rd Reason:- Throughout the reign of Queen Elizabeth I, and the beginning of King James I reign, there were none less than sixteen plots against England and Protestantism. Eleven of them were major plots. **Due to God's providence, all of these plots ended in failure.** They are known and remembered by the names of their leaders: 1. **Ridolfi**, 2. **Saunders**, 3. **Gregory XIII**, 4. **Campion**, 5. **Parsons**, 6. **The Duke of Guise**, 7. **Allen**, 8. **Throgmorton**, 9. **Parry**, 10. **Babington**, 11. **Sixtus V**, 12. **Philip II of Spain**, 13. **Yorke**, 14. **Walpole**, 15. **Southwell**, and 16. **Guy Fawkes**.

4th Reason:- The Millenary Petition. After accepting the terms of the Millenary Petition from a thousand ministers, who were led by Dr. Reynolds, King James authorised the translation of the Bible into English, without comment or note. This translation was to be called the King James Version. The KJV was to counteract the

damage that the Jesuit Rheims Bible was spreading among the English people at that time. The Puritans considered this Bible of the Jesuits as poisonous and corrupt. They were sure that this Bible was eroding the spiritual fabric of the nation. Therefore the KJV was to be more accurate, and free from any corrupting errors. This act of authorisation put the King and his government in direct opposition against Rome and the notorious Jesuit order.

And we at VITW believe this was the fundamental reason for causing the seed of hatred to germinate in the Gunpowder Treason and Plot.

THE PLOT

Philip Sidney in his book ‘**A History of the Gunpowder Plot**’ states:

“The vague idea of blowing up the Parliament House seems to first have occurred to Robert Catesby (about Lent, 1604.) ... later on after the admission of Percy into the conspiracy, an empty house, with a small garden, adjoining the Palace of Westminster was hired. This house rented in Thomas Percy’s name, was leased by one Ferris as tenant to Mr. Whyneard, keeper of the King’s wardrobe. From a cellar in this house the conspirators began digging a mine through the wall into the contiguous vault beneath the Parliament house; but the work proved much harder than anticipated, as the wall was immensely thick - nearly nine feet - and all the rubbish displaced in the course of their toil had to be buried in the garden. In December, 1604, they suddenly learned that the meeting of Parliament had been prorogued (*discontinued*) till October 3rd. The conspirators, therefore, took a holiday until after Christmas before resuming their labours ... one day they were startled by hearing a peculiar rumbling noise over their heads. Guy Fawkes, who acted as a kind of outside porter and sentinel to the confederates engaged within, on enquiry found that the tenant of the cellar almost above them was removing, and his coals (in which he traded) were taken away. Percy immediately hired this cellar on the pretext that he wished to use it to keep fuel and coal. He had not taken it more than a month before he and his confederates, having

abandoned their now unnecessary task of digging through the lower wall, had succeeded in depositing within it barrels of gunpowder brought by water from their house at Lambeth.”³

THE FAILURE OF THE PLOT

We stated before that the Secretary of State’s men were closely monitoring the progress of Romanists in England. But one of the most fatal mistakes made by Catesby since the conspiracy was planned, was the selection of Francis Tresham. Catesby was aware of Tresham’s unreliable character, but the wealth that this new recruit could supply to the purse of this conspiracy, was too strong for him to resist.

Furthermore, his friendship with several of the Roman Catholic peers, two of whom had married his sisters, was a situation that could be used for the furtherance of the plot. ***BUT IT WAS FOR THIS REASON THAT THE PLOT FAILED!***

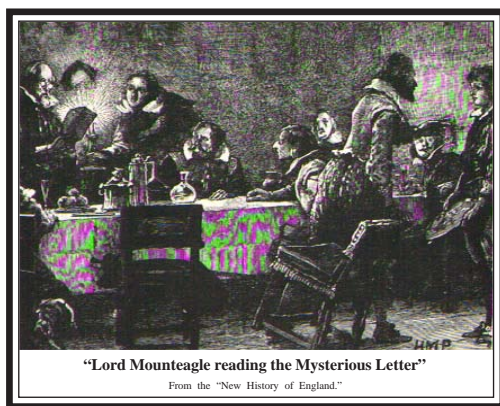
On October 18, “at a house called White Webbs, on the confines of Enfield Chase; a building, the secret chambers of which had more than once afforded harbours of refuge to Priests, and especially Jesuits ... they received a visit from Tresham, who appeared to be very much dejected. He came to them, he said, in a state of terrible anxiety. His conscience pricked him. He couldn’t obtain no peace of mind until they had satisfied him on one important point, namely, might he be allowed to warn his two noble relatives of their danger?”⁴

It has been said that Tresham had already warned one of his relatives of the plan to blow up Parliament, and that his purpose of visiting Catesby was not to save the Roman Catholic peers, but to offset the whole plan of destruction. On October 26 occurred an event which will ever remain memorable in the history of England. It sealed the fate of all the conspirators engaged in this plot to destroy our throne and our government. **This event was the receipt of the famous anonymous letter sent to Lord Mounteagle.**

Before dealing with the contents and the strange circumstances in which Lord Mounteagle received this letter, it will be fair to state that many of the conspirators were uneasy in allowing the destruction of Roman Catholic peers. But they did not know how to do this

without divulging the existence of their plot. Hence the famous Jesuit principle came into practice, that ‘good becomes evil and evil becomes good when it furthers the aims of the Roman Church.’ Catesby at this time was aware that Tresham, if not given what he wanted, would have gone to the authorities.

The Letter



Late on Friday October 25, Mounteagle gave orders that he would stay at his house in Hoxton. This short notice surprised even his servants. At Hoxton, at about 7 pm, just as he was preparing for supper, one of his footmen whom he had sent on an errand over the street, was met by an unknown man of a reasonably tall stature, who delivered him a letter. This letter was immediately brought to Lord Mounteagle, who handed it to a gentleman in his household named Warde. He was told to read it aloud. We will quote from the original letter which is kept at the Record Office.⁵ There is also a copy in Dom. S.P. James I., November, 1605, vol. xvi.

* “my lord out of the love I beare to some of youere frends i have a caer of your preservaecion therfor I would advyse yowe as yowe tender youer lyf to devyse some excuse to shift of your attendance at this parleament for god and man hathe concurred to punishe the wickedness of this tyme and thinke not slightlye of this advertisment but retyere youre self into youre countri wheare yowe maye expect the event in safti for thowghe there be no apparence of ani stir yet I say they shall receyve a terrible blowe this parleament and yet they shall not seie who hurrts them this council is not to be contemned because it maye do yowe good and can do yowe no harme for the dangere is passed as soon as yowe have burnt the letter and I hope god will give yowe the grace to mak good use of it to whose holy protecion I comment yowe.”

**(This letter was written at a time that there was a different style of English spelling - the dictionaries that we have today have evolved*

from Caxton’s Press, and the English Bible and Prayer Book, a testimony to the authority of God’s Word.)

It should be noted that Warde, who read the letter aloud, was an intimate friend of Thomas Winter, one of the chief conspirators. This letter that was received by Mounteagle, was passed on to Robert Cecil, and after examination before the Privy Council, it was handed to King James.

Lord Mounteagle, whose name was William Parker, is known to historians by his earlier title as Lord Morley. At the receipt of this mysterious letter, he was around 31-32 years old. He was married to the sister of Francis Tresham, and was a personal friend of Father Henry Garnet S.J and Robert Catesby. He was also involved in the Essex Rebellion and had been heavily fined for his pains. Lord Mounteagle was a staunch Roman Catholic of the faction under Father Garnet and his colleagues, and was in agreement with the missions of the Jesuits at that time. But at the accession of James I, he suddenly changed his politics and religion, and outwardly conformed to the Protestant religion. It is said that he told King James himself that he wanted to become a Protestant. But he was always a Catholic at heart. He merely conformed outwardly for political reasons, and the protection of his purse. And for this reason it is believed that he was actively involved as a spy for Cecil.

Great care had been taken on the part of the then government to disclose the fact that Lord Mounteagle had been a double agent, working for both the church and Cecil. The government employed the most peculiar and coercive methods to prevent all knowledge of his former treasons to be brought to light, especially at the trial of the conspirators, and at the trial of Garnet. Philip Sidney states in his book that: “all evidence tends to show that the letter was designed for Mounteagle’s own protection, and that he could see no other way of clearing himself from being considered a traitor to his friends than by obtaining an anonymous warning of the kind actually received.”⁶

The Bible warns that: “A double minded man is unstable in all of his ways.” (James 1:8) Lord Mounteagle surely was, as history declares.

It is often wondered, if Cecil knew of the plot before and after the reception of the anonymous letter, why he did not make his move earlier. But as the saying goes patience is a virtue. It is believed that he waited until the fruition of the plot so that all those involved would be recognised and captured, and dealt with according to the sentence of the times.

THE CAPTURE AND CONFESSION



To this very day, the search of the cellars of the House of Lords still takes place on the eve of the Opening of Parliament.

At this point we will give a brief overview of the final capture of the conspirators. On November 1st, Catesby having sent for Tresham, interviewed him in the presence of Thomas Winter and Barnet. He was charged with having written the letter to Lord Mounteagle, but he denied this accusation with many oaths. And due to a lack of evidence, they reluctantly let him go free. On November 3rd, Warde sent an urgent message to Catesby, informing him that the letter had been delivered to the King. The panic stricken conspirators sent for Tresham, and interviewed him at dusk near Lincoln's Inn. After bitter conversation, Tresham denounced the plot and implored all his confederates to leave England at once. Time was too short to warn Guy Fawkes, and hence he remained in London. On November 4, early in the afternoon, Fawkes whilst in his cellar was surprised by a sudden visit by Mounteagle and Lord Chamberlain, who asked him to whom belonged this large store of fuel. Fawkes replied that he was Percy's servant, and that the store belonged to him. No attempt was made to look beneath the fuel, and

so Fawkes concluded that they had not suspected the presence of the powder contained in thirty-six casks. And Fawkes as a result stood loyal to his post of duty. At a little before midnight, Fawkes was captured just outside the house, by a body of men under Sir Thomas Knyvet, and the gunpowder was discovered beneath the fuel. He was immediately taken before the Privy Council, and was actually brought before the King in his bedchamber before 4 am. Soon after dawn, the streets were filled with people talking of the plot. Horror and dismay were depicted on every countenance, and it was rumoured that a general rising of the Roman Catholics was imminent. The Spanish ambassadors house was mobbed. The train-bands were called out, and the general alarm reminded the Londoners of the preparations made in 1588 against the coming of the Armada. 'Not only that night,' writes the Venetian Ambassador, 'but all next day; the citizens were kept under arms.'

On the run

The conspirators realising that all was lost made for a quick escape from the capitol. Percy and Christopher Wright rode off first, then Keyes, then Rookewood followed. Rookewood was travelling so fast that he managed to overtake Keyes, and en-route met with Catesby and John Wright. It is said that he completed eighty miles in less than eight hours.

Soon afterward Percy and Christopher Wright joined them, and then all five of the conspirators headed to *Dunchurch*, via Ashby St. Legers, the house of Catesby's mother, leaving Keyes behind. They had a short stay at Dunchurch, and the rapidity of the journey arose the suspicion of certain country gentleman, and the loyal fighting men in the shires of Warwick, and Northampton, including even some Roman Catholics, who took arms in support of the Crown.

Sir Richard Walshe, Sheriff of Worcestershire, stayed close to the conspirators until they were inside the walls of Holbeach House (four miles from Stourbridge). Within this place he waited with equanimity (patience) for the arrival of men marching to his aid, for he knew that the terrorists were caught within a trap.

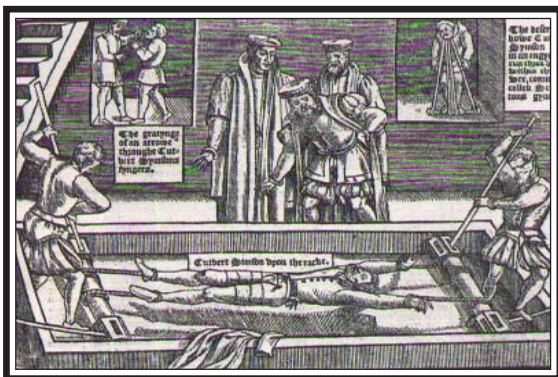
The Battle of Holbeach House

Before the commence of the battle, occurred an event that is so shrouded in mystery, that one has to ask if God's providential hand was moving in the affairs of England. This event was the final blow to dishearten the superstitious Roman Catholic terrorists. Catesby and company, who planned to blast the Crown and the government into eternity nearly received what they planned to give. Some gunpowder which the terrorists had brought with them became damp during their escape, because of the bad weather. And whilst leaving it to dry, a live coal jumped out of the fire and ignited the powder. Although there were no deaths, there were many narrow escapes, and in the process of the blast Catesby and Rookwood were severely scorched.

At 11am on November 8th, the Sheriff of Worcester gave the order to storm the garrison at Holbeach House. In the battle that commenced Percy, Catesby and the Wright brothers met their fate. Ambrose Rookwood and Thomas Winter were badly wounded, but recovered. Rookwood, Thomas Winter and Grant were taken to the Tower of London. Keyes was captured in Warwickshire on November 9, and also taken to the Tower of London. Out of the 13 conspirators originally engaged in the act of terrorism, no less than 11 were either captured or killed within five days of November 5th.

No mercy given

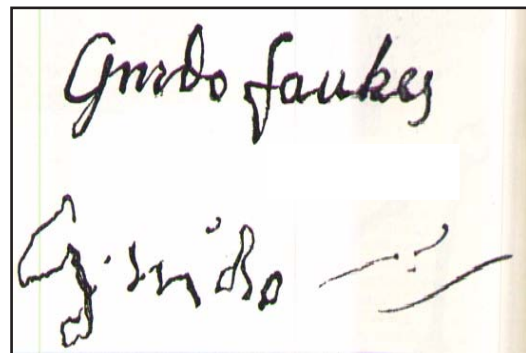
The dead heads of Percy and Catesby were cut off and set at the ends of the Houses of Parliament. By the 12th November Tresham was under lock and key, and Robert Winter was in hiding. But within two months he was also in the Tower.

Within the Tower

Guy Fawkes was the first of the plotters to be incarcerated within the Tower. As he refused to co-operate, and incriminate his friends, he was speedily put to torture. By the King's direction, he was subjected to the gentler torments first, and then gradually to the more severe. On November 9th, Guy Fawkes disclosed full details of the meeting which took place at the house near St. Clements Inn. He also stated that Father Gerard S.J administrated the Sacrament.

And on November 17th, Guy Fawkes made a full confession of his part in the plot. All conspirators eventually confessed.

The trial and execution

Out of the original number of thirteen, only eight of the conspirators survived to be committed to trial. These eight were Thomas Winter, Guy Fawkes, John Grant, Robert Winter, Ambrose Rookwood, Thomas Bates, Robert Keyes and Everard Digby. All except Sir Everard Digby pleaded not guilty. Thomas Winter asked that he might be hanged for himself and for his brother. Thomas Bates and Robert Winter craved mercy. Ambrose Rookwood acknowledged that his offence was so heinous, that he deserved the indignation of the King and lords, and the hatred of all the commonwealth. The Lord Chief Justice (Sir John Popham) finally passed a sentence of death.

The conspirators met their fate with courage, considering the terrible nature of their punishment. Tied to separate hurdles, they were dragged, lying bound on their backs, through the

muddy streets to the place of execution, there to be first hanged, cut down alive, drawn, and then quartered.⁷

THE JESUITS AT HENDLIP



Thus far we have covered the trail of the Roman Catholic laymen who were involved in the Gunpowder Treason and Plot. Our present aim is to focus on the involvement of the Roman Catholic priest who played an active role in this great act of treason. We are obliged at this point to focus on the daring adventures of members of the famous Society of Jesus, better known as the **Jesuit Order**.

Father Henry Garnet, the superior of the Jesuits in England, after the capture of the rebels at Holbeach, and the flight of his colleague Oswald Greenway, became a fugitive on the run. He stayed at a place called Coughton, but on December 6, he fled to Hendlip House nearly four miles north-east of Worcester, where his friend, Father Oldcorne, alias Hall, lay concealed.

Hendlip House was the property of Thomas Abington. Thomas Abington was a very remarkable person. He had been for over five

years imprisoned in the Tower of London for his part that he played in the Babington Plot. This was for the work that he did for Mary Queen of Scots. His house was fortified with priest's holes, or what we could say secret hiding places. According to Father Gerard in his narrative on the Gunpowder Plot, these secret chambers were the craftsmanship of one Nicholas Owen, who was commonly called Little John. His chief employment was in making secret places to hide priests and church stuff. It is said that no Catholic had done a work so great, for the furtherance of Rome's aims to conquer England, than himself.

Patience is a virtue

On Sunday January 19, 1606, Sir Henry Bromley, a magistrate, appeared before Hendlip early in the morning with a army of a hundred men, armed with all manner of weapons. He was working directly under the instructions of Salisbury. By the time he entered, all four Jesuits were hidden away. Garnet and Oldcorne in one place, Chambers and Owen in another. On the 23rd, because of hunger and cold and confinement, Owen and Chambers came out of their place. Had they had a little patience, all four would have escaped, because Bromley was ready to leave.

Father Garnet writing from the Tower of London on March 2, to his lady friend Ann Vaux, tells of his own capture: "After we had been in the hole 7 days and 7 nights, and some odd hours, every man may well think we were wearied; and indeed so it was, for we continually sat, save that

some times we could half stretch ourselves, the place being not high enough; and we had our legs so straightened, that we could not sitting find place for them, so that we both were in continual pain of legs, and both our legs, especially mine, were much swollen, and mine continued so till I came to the Tower.’’⁸ In Philip Sidney’s book it is also said that marmalade and other sweet meats were found lying in the secret hole or hiding place where they were hidden away. They were also more fully sustained by a quill or reed, through a little hole in a chimney, that was connected to their next door neighbour. Through this passage drinks, like broths and soups, were safely conveyed to them. With this type of sustenance, it was said by Garnet, that had he had half a day to clear the place from books and furniture, and proper sanitation, he could have endured for a quarter of a year. If it was not for the cramped conditions and the lack of proper hygiene, the world would have never known the extent and involvement of the Roman Catholic Jesuit Order’s role in the plot.

THE LASTING EFFECTS OF THE GUNPOWDER PLOT

When we look at the history of England, and the many plots and schemes that have germinated against this Protestant nation, there can be no doubt that the Gunpowder Treason and Plot was of great significance. The consequences of its failure and conception settled the question of whether the Roman Catholics could recover the power that they had under the reign of Mary Tudor (or Bloody Mary). **The failure and capture of the conspirators settled in the mind of the English people, and government, once and for all, that Papal Rome is the enemy of civil and religious liberty.**

The eventful date, the 5th of November, was not allowed to be forgotten by the public. A special service of thanks to heaven, for the failure of the Plot was added to the book of Common Prayer. And every successive anniversary of the 5th of November was celebrated as a feast-day, or rather if we can use such a word, feast-night, in every town and village throughout England. As a result of this diabolical scheme, fresh laws were passed against all Roman Catholics, whether they were rich or

poor, free or bond. The following are laws that came into operation as a consequence of the Plot, designed specifically to place all Romanists under the iron rule of the government:

1. They (Roman Catholics) were forbidden to appear at Court;
2. They were forbidden to dwell within ten miles of London;
3. They were not allowed to remove five miles from their homes, without permission of the neighbouring magistrates;
4. They were not allowed to become doctors, clerks, lawyers, or members of corporations;
5. They were inhibited from presenting to Livings (a person with a position as a vicar or rector with an income or property);
6. They were forbidden to act as executioners or trustees;
7. Married Roman Catholics, unless they had been united by Protestant clergyman, held no legal right to property accruing to either party by marriage;
8. Every Roman Catholic, educated on the continent became *ipso facto* an outlaw;
9. The houses of Roman Catholics might be broken open and searched, on the order of a single magistrate, at any time, and under any pretext, however shallow;
10. Every Protestant entertaining a Roman Catholic visitor, or employing a Roman Catholic servant, was liable to a heavy fine;
11. Any Roman Catholic refusing to deny his or her belief in the deposing power of the Holy See became liable to perpetual imprisonment.

Soon after the death of Garnet, James offered some considerable relief to those Roman Catholics who refused to acknowledge the

deposing power (to remove from office, especially to dethrone Kings or Queens) of the Roman Pontiffs. And many agreed to accept the proposal made to them. With James offering this relief, there came a division amongst all Romanists, which resulted in two parties: the one ready to acknowledge James and abjure the deposing power of the Pope; the other refusing to acknowledge James, and ready to exalt the doctrine of the deposing power, into the position of an infallible or obligatory article of faith. Whichever way that it can be looked at, there was no peace. The loyal English Roman Catholics who sided with James, were attacked

from Canterbury and from Rome. And if they professed an outward belief in Protestantism, by attending their parish church, they were ruined with fines and laws: and so by acknowledging James as their King, they were condemned by the head (Pope) of that very faith for which they had sacrificed so much for.

THE JESUITS

THE JESUITS FOUND TO BE THE MAIN PERPETRATORS OF THE GUNPOWDER PLOT

Much has been said of the activities of certain lay brothers, in the attempt to destroy the Houses of Parliament. But at this time we will observe the role of the **Society of Jesus** (*The Jesuits*).

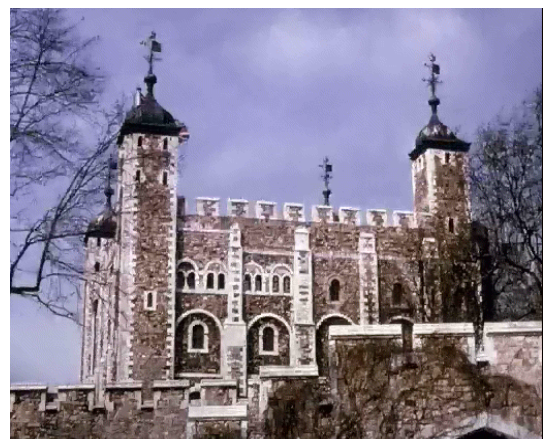
Henry Garnet, superior of the Jesuits in England, was aged about fifty to fifty one at the time of his death. Although brought up a Protestant, and a student of Oxford University, and after leaving school becoming a corrector of the press; after serving a printer for two years he went abroad and became a Romanist. And in about 1575 he became a member of the Society of Jesus. Father Garnet's role as the superior of the Society was not an easy one, for he walked in the shadows of men like Parsons and Weston.

The secret letters

Sir Everard Digby, when a prisoner in the Tower of London, found a means of smuggling out letters without detection. If you write on scraps of paper with lemon juice, it seems outwardly as if there is nothing on paper. But by putting these letters over a fire, the recipient can decipher what is written, for the invisible writing lights up through the heat of the flame. Thus a way of communication was set up between Digby and his Jesuit conspirators.

These letters have been ignored as much as

possible by Jesuit writers, for the mere fact that they imply the involvement of Rome's military order. The whole tone of Digby's disclosures suggests clearly that the writer laboured under the impression that the Jesuit leaders knew of the plot and tacitly (silently) approved of its purpose. 'For my keeping it secret,' says Digby, 'it was caused by certain belief, that those which were best able to judge of the lawfulness of it had been acquainted with it, and given away unto it. More reasons I had to persuade me to this belief than I dare utter.' Later on, he writes, 'Before I knew anything of the plot, I did ask Mr. Farmer (Garnet) what the meaning of the Pope's brief was; he told me that they were not (meaning priests) to undertake or procure stirs, yet they would not hinder any, neither was it the Pope's mind that they should.'¹

**Father Garnet's last letter to Anne Vaux,
written on April 21, 1606**

The principal charges brought against the Jesuit Provincial (Father Garnet), all of which he was shown to have been guilty of are as follows:-

THE INDICTMENT'S AGAINST FATHER GARNET

‘(1). He had been a party to sending Sir Edward Baynham to Rome. Baynham, a man of bad character, was (as Faukes explained) to inform the Pope of the result of the Plot, had it succeeded.

‘(2). He had heard of the Plot (outside the confessional) from Father Greenway.

‘(3). He knew, from two conversations with Catesby, that the plot was in active progress.

‘(4). He sent Father Greenway to visit the conspirators at Huddington.

‘(5). On All Saints Day, 1605 (Nov. 1st), he asked his congregation at Coughton, to “pray for some good success for the Catholic cause at the beginning of Parliament” (Nov. 5th).

‘(6). He made no (known) attempt to save the Parliament from its doom.’²

And here is the actual confession from Father Henry Garnet himself:

“I, Henry Garnet, of the Society of Jesus, priest, do here freely protest before God that I hold the late intention of the Powder action to have been altogether unlawful and most horrible; as well in respect of the injury and treason to his Majesty, the Prince, and all others that should have been sinfully murdered at that time; as also in respect of infinite other innocents which should have been present. I also protest that I was ever of opinion that it was unlawful to attempt any violence against the King's Majesty and the Estate, after he was once received by the Realm. Also I acknowledge that I was bound to reveal all knowledge that I had of this or any other treason out of the Sacrament of Confession. And whereas, partly upon the hope of prevention, partly for that I would not betray a friend, I did not reveal the general knowledge of Mr. Catesby's intention, which I had of him. I do acknowledge myself highly guilty, to have offended God, the King's Majesty and Estate, and humbly ask all forgiveness; exhorting all Catholics whatsoever, that they in no way build on my example; but by prayer and otherwise seek the peace of the Realm, hoping in his Majesty's merciful disposition that they shall enjoy their wonted quietness and not bear the burden of mine or others' defaults and crimes.

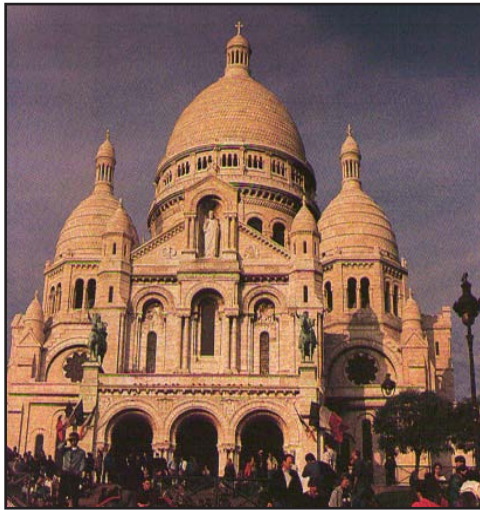
In testimony hereof I have written this with my own hand, 4th April.”
HENRY GARNET, S.J.³

It is important to note that when we understand the autonomy of the Jesuit Order, these charges have a bearing upon the whole hierarchy of the Papal Military Machine. Because with the famous and scrupulous teachings of blind obedience: “Ignatius requires nothing less than the complete sacrifice of the man's own understanding, ‘unlimited obedience even to the very sacrifice of conviction.’ ”... He taught his Jesuit members by a complete “corpse-like obedience” to be governed by the following principle: “ ‘I must let myself be led and moved as a lump of wax lets itself be kneaded, must order myself as a dead man without will or judgement.’ ”⁴ The point to be ascertained from these statements is that each Jesuit works from direct orders from his superiors. So according to the Jesuit teachings, Garnet and his fellow accomplices were acting under orders from a chain of command, for no Jesuit operates under the basis of individual conscience. He is like a piece of clay in the potter's hand.

WHO ARE THE JESUITS?

The Society of Jesus, commonly called the Jesuits, is a secret order of the Roman Catholic Church. It was founded on Assumption Day, 1534, which fell on the 15th of August of that year, in the Chapel of Notre-dame de

Montmartre by Spanish Cavalier, **Ignatius Loyola**. The order was sanctioned by Pope Paul III in September 27th 1540.



The chapel where the Society of Jesus (Jesuits) was first constituted, the Notre Dame Church in Montmartre, now called the Sacre Coeur (Sacred Heart). Below is a stained glass picture of Ignatius Loyola, the founder of the Jesuit Order.



Loyola had received military training, and when he had been an extreme religious enthusiast, he conceived the idea of forming a *spiritual militia*, to be placed at the service of the Pope. The Jesuit order emerged at the same time that King Henry VIII reigned in England. But they did not have a formal mission in England until Queen Elizabeth I had passed twenty years of her reign. The world's most famous female author, E. G. White, describes the militia of Rome as thus:

"... the most cruel, unscrupulous, and powerful of all the champions of Popery. Cut off from earthly ties and human interests, dead to the claims of natural affection, reason and conscience wholly silenced, they knew no rule, no tie, but that of their order, and no duty but to extend its

power. The gospel of Christ had enabled its adherents to meet danger and endure suffering, undismayed by cold, hunger, toil, and poverty ... in face of the rack, the dungeon, and the stake ... Jesuitism inspired its followers with a fanatascism that enabled them to endure like dangers ... There was no crime too great for them to commit, no deception too base for them to practice, no disguise too difficult for them to assume. Vowed to perpetual poverty and humility, it was their studied aim to secure wealth and power, to be devoted to the overthrow of Protestantism and the re-establishment of the Papal supremacy. When appearing as members of their order, they wore a garb of sanctity, visiting prisons and hospitals, ministering to the sick and the poor, professing to have renounced the world, and bearing the sacred name of Jesus, who went about doing good. But under this blameless exterior the most criminal and deadly purposes were often concealed. It was a fundamental principle of the order that the end justifies the means. By this code, lying, theft, perjury, assassination, were not only pardonable but commendable, when they served the interests of the church. Under various disguises the Jesuits worked their way into offices of state, climbing up to be the counsellors of kings and shaping the policy of nations. They became servants to act as spies upon their masters. They established colleges for the sons of princes and nobles, and schools for the common people; and the children of Protestant parents were drawn into an observance of popish rites."⁵

THE BLACK POPE

In the Vatican there is primarily two popes: the Black Pope and the White Pope. "The world little realises how much that fact means. The White Pope is the one we generally know and speak of as the Pope, but the real power is in the hand of that body directed by the Black Pope. The Black pope, which name does not refer to colour, is the head of the Jesuits - an organisation which, outside of God's people, is the mightiest that history has ever known."⁶ Philip Sidney in his book *Modern Rome in Modern England* states: "The power of the General of the Jesuits is, or was, almost equal to that of the Holy Father ... The labours of the

General are prodigious (*immense*). No individual in the world receives, and answers so many letters. In the archives of the Jesuit head-quarters are preserved enormous registers, wherein the names of all members of the society are enrolled, together with prolific personal notes relating to the societies friends, and especially its foes, the frailties of a woman, the secret policy of a minister, the income of some opulent merchant, the (liberalism) of some exalted ecclesiastic are, *inter alia* (*among other things*), all chronicled here. The Jesuit obtains exact information about the inner life of every foeman worthy of his steel - about his friends, his source of wealth (or his debts), his movements, his projects, his past.”⁷

THE WORLD-WIDE SURVEILLANCE OPERATIONS OF THE JESUITS

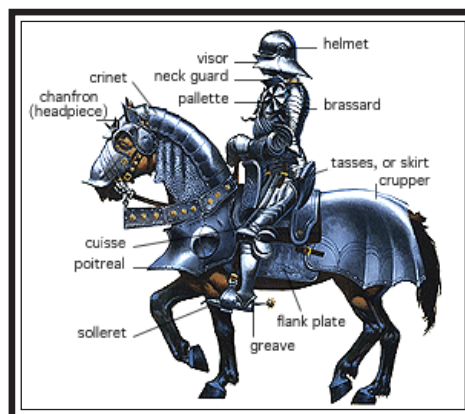


A spiritual militia manipulates the world behind the scenes

The Society of Jesus has one of the most sophisticated networks of information retrieval on the face of this planet. And this is one of the reasons for their overwhelming success in keeping the Vatican as one of the world’s most potent superpowers.

As Paul in the book of Ephesians (6:13-17) admonishes Christians to put on the whole armour of God, the Jesuit is to be clothed in the whole armour of Ignatius Loyola. Doctor J. A. Wylie in book 15 of *The History of Protestantism*, ch. 6, p. 404, describes the whole armour of Loyola as thus: “He has his “loins girt about with” **mental** and verbal **equivocation**; he has “on the breastplate of” **probabilism**; his “feet are shod with the preparation of the” *Secret Instructions*. “Above all, taking the shield of” **intention**, and rightly handing it, he is “able to quench all the fiery darts of” human remorse and Divine threatenings. He takes “for an helmet the hope of” Paradise, which has been most surely promised him as the reward of his services; and in his hand he grasps the two-edged sword of a

fiery fanaticism, wherewith he is able to cut his way, with prodigious bravery, through truth and righteousness.”



The concept of armour is an old one, and has to do with war, and protection

In order to understand what the implications are of having men living by these rules in society, we need to reveal the spirit that these teachings imbue in the minds of these individuals. With the doctrine of *Probability*, “almost any crime might be condoned, if only some sort of excuse can be found for it.”⁸ With the doctrine of *Mental Reservation*, “By this a man may properly swear that he has not done a deed which yet he has done, if he add mentally to his oath ‘I have not done it’ the words ‘on a certain specified day’ or ‘before I was born.’ ”⁹ They are also taught that it is the “*Intention* which stamps the quality of an action; so that it is no perjury nor untruth to say in an audible voice ‘I swear that I did not do it’ if the word ‘to-day’ be added inwardly; for then there was no intention to swear to the general statement, but only to the particular, which was true.”¹⁰ These teachings are set forth, for example, in the Jesuitical books of Moral Theology by Sanchez and Filutius, and are totally contradictory to the true word of God, which teaches that “to him that knoweth to do good, and doeth *it* not, to him it is sin” (**James 4:17**).

Modes of operation

It would be appropriate at this time to investigate the methods of operation for the world’s most formidable, and experienced intelligence agency. We are told by Dr. Wylie, in his book *The History of Protestantism*, that war brought to light the secret power of how the

Jesuits kept the Roman church afloat during the Protestant Reformation. “If the Jesuits had not come forward and offered to save the situation, to-day there might not be a Catholic Church.”¹¹ It is important for us to unveil the standard constitution for covert Jesuit operations. This constitution is in the book the Secret Instructions (*Secreta Monita*). “The Duke of Brunswick, having plundered the Jesuit’s college at Paderborn in Westphalia, made a present of their library to the Capuchins of the same town. Among the books which had thus come into their possession was found a copy of the *Secret Instructions*. Another copy is said to have been discovered in the Jesuits’ college at Prague. Soon thereafter reprints and translations appeared in Germany, Holland, France, and England. The authenticity of the work was denied, as was to be expected; for any society that was astute enough to compile such a book would be astute enough to deny it. To only the fourth or highest order of the Jesuits were these *Instructions* to be communicated; the others, ... were ignorant of them in their written form.”¹² These instructions were based upon:

- 1) How to raise up establishments.
- 2) To find out the wealth of their districts.
- 3) To draw the youth around them.
- 4) How to obtain the friendship of great men.
- 5) How to manage princes, and direct their policy.
- 6) How to conduct their embassies.
- 7) How to get close to widows, and keep them from having second marriages, in order that they could bequeath their estates to the Society.
- 8) To visit hospitals.
- 9) To discover the revenues and heirs of noble houses.

There are others things that should not be written, for they are corrupting to the mind.

These instructions that are given to the fourth degree of the Society of Jesus, are what gives them their power to infiltrate society, and accumulate wealth to further their goal - **which is total global supremacy, spearheaded by the Roman Catholic Church.**

THE EXTREME OATH OF THE JESUITS

There are four classes of Jesuits. The first class is the **Novitiates** - the second, **Neophyte** (new convert) - the third, **Coadjutors** (an assistant to the main priest) - and the fourth, The **Professed**. While it would be fair to say that the first three levels might be ignorant concerning books like the Secret Instructions, and other clandestine operations of the highest level of the Jesuits, when one considers the extreme oath of induction of the professed or fourth level of the Society, all doubts of speculation are wiped away, for this oath is incriminating (revealing the criminal nature of the Society).

Its principles are contrary to Christianity, and the reader, once they take the time to study the excerpts from it, must surely agree that the Jesuits have no right to call themselves a Christian organisation. A true Christian would rather die, than carry out the monstrosities that the Jesuits swear to do under this oath.

The following is an extract from portions of the Jesuit “Extreme Oath of Induction” as recorded in the Congressional Record of the United States of America, February 15, 1913, pages 3215-6. “EXTREME OATH OF INDUCTION”

“My son, heretofore you have been taught to act the dissembler: among the Roman Catholics to be a Roman Catholic, and to be a spy even among your own brethren; to believe no man, to trust no man. Among the reformers, to be a reformer; among the Huguenots, to be a Huguenot; among the Calvinists, to be a Calvinist; among the Protestants, generally to be a Protestant; and obtaining their confidence to seek even to preach from their pulpits, and to denounce with all the vehemence in your nature our holy religion and the Pope; even to descend so low as to become a Jew among the Jews, that you might be enabled to gather together all information for the benefit of your order as a faithful soldier of the Pope. You have been taught to insidiously plant the seeds of jealousy and hatred between states that were at peace, and incite them to deeds of blood, involving them in war with each other, and to create revolutions and civil wars in communities, provinces and countries that were independent and prosperous, cultivating the arts and the science and enjoying the blessings of peace. To take sides with the combatants secretly in concert with your brother Jesuit ... who might be engaged on the other side, but openly opposed to that with which you might be connected; only that the church might be the gainer in the end, in the conditions fixed in the treaties for peace and that the end justifies the means.

“You have been taught your duty as a spy, to gather all statistics, facts and information in your power from every source; to ingratiate yourself into the confidence of the family circle of Protestants and heretics of every class and character, as well as that of the merchant, the banker, the lawyer, among the schools and universities, in parliaments and legislatures, and in the judiciaries and the councils of state, and to ‘be all things to all men,’ for the Pope’s sake, whose servants we are unto death.

“You have received all your instructions heretofore as a novice, a neophyte, and have served as a coadjutor, confessor and priest, but you have not yet been invested with all that is necessary to command the army of Loyola in the service of the Pope. You must serve the proper time as the instrument and executioner as directed by your superiors; for none can command here who has not yet consecrated his labours with the blood of the heretic; for ‘without the shedding of blood no man can be saved.’ Therefore, to fit yourself for your work and make your salvation sure, you will, in addition to your former oath of obedience to your order and allegiance to the Pope, repeat after me.

“I _____, now in the presence of the Almighty God, the Blessed Virgin Mary, the Blessed Michael the Archangel, the Blessed St. John the Baptist, the Holy Father, the Superior General of the Society of Jesus, founded by St. Ignatius Loyola, in the Pontification of Paul the Third, and continued to the present, do by the womb of the virgin, the matrix of God, and the rod of Jesus Christ, declare and swear that his holiness, the Pope, is Christ’s Vice-regent, and is the true and only head of the Catholic or Universal Church throughout the earth; and that by the virtue of the keys of binding and loosing, given to his Holiness by my Savior, Jesus Christ, he hath power to depose heretical kings, princes, states, commonwealths and governments, all being illegal without his sacred confirmation, and that they may be safely destroyed.

“I do further declare, that I will help and assist and advise all or any of his Holiness’ agents in any place wherever I shall be, and do my utmost to extirpate the heretical Protestant or Liberal doctrines and to destroy all their pretended powers, legal or otherwise.

“I do further promise and declare, that notwithstanding I am dispensed with to assume any religion heretical, for the propagating of the Mother Church’s interest, to keep secret and private all her agents’ counsels, from time to time as they may instruct me, and not to divulge directly or indirectly, by word, writing, or circumstances whatever; but to execute all that shall be proposed given in charge or discovered unto me, by you, my ghostly father ...

“I do further promise and declare, that I will have no opinion or will of my own, or any mental reservation whatever, even as a corpse or cadaver (perinde ac cadaver) but unhesitatingly obey each and every command that I may receive from my superiors in the Militia of the Pope and Jesus Christ.

“That I will go to any port of the world, whatsoever, without murmuring and will be submissive in all things whatsoever communicated to me ... I do further promise and declare, that I will, when opportunity presents, make and wage relentless war, secretly and openly, against all heretics, Protestants and Liberals, as I am directed to do to extirpate and exterminate them from the face of the whole earth, and that I will spare neither sex, age nor condition, and that I will hang, waste, boil flay, strangle and bury alive these infamous heretics; rip up the stomachs and wombs of their women and crush their infants’ heads against the wall, in order to annihilate forever their execrable race.

“That when the same cannot be done openly, I will secretly use the poison cup, the strangulation cord, the steel of the poniard, or the lead bullet, regardless of the honor, rank, dignity or authority of the person or persons whatsoever may be their condition in life, either public or private, as I at any time may be directed so to do by any agent of the Pope or superior of the Brotherhood of the Holy Faith of the Society of Jesus.”

The Jesuits in Great Britain



Stonyhurst College, Lancashire, England

The Jesuits settled in England at Stonyhurst, an Elizabethan house, in Lancashire, bequeathed to them by a Roman Catholic squire, and started their now famous school. Among Protestants, these Jesuits were generally known as ‘Gentlemen from Liège.’ The following is a list of English and Welsh places in which the Jesuits possess houses and churches: Blackpool, Bournemouth, Bristol, Bury Saint Edmonds, Chesterfield, Denbigh, Leigh, Liverpool, London, Manchester, Mold, Old Windsor, Oxford, Preston, Rhyl, Richmond (Yorks), Roehampton, Saint Asaph, St. Helier (Jersey), Saint Helens, Shipton, Stonyhurst, Wakefield, Wardour Castle (Wilts), Wigan, Wimbledon, Worcester, Yarmouth, Canterbury, St. Leonards-on-Sea, Prescott, Accrington, Billington, Clitheroe, Holywell, and Petworth.¹³

“Writing in 1965 Avro Manhattan, an authority on Roman Catholicism in politics, described them (the Jesuits) as ‘the ecclesiastical storm-troopers of the Catholic Church,’ and remarked that ‘it is most significant that in two traditionally English speaking Protestant countries, Great Britain and the USA, they have their largest contingents.’”¹⁴

We have with us an original (Fifth Edition) copy of *The Secret History of the Oxford Movement*, written by Walter Walsh in 1899. This book is a definitive work on how the Jesuits captured Oxford University and destroyed Protestantism in Great Britain. Walter Walsh stated: “I am not one of those who suffer from ‘Jesuitism on the brain,’ and I do not, so to speak, see a Jesuit round every street corner. But I certainly am inclined to attach a good deal of importance to the revelations made by the late Rev. Dr. Desanctis, formerly parish priest of the

Madallena, Rome, Professor of Theology, Official Theological Censor of the Inquisition, and subsequently Minister of the Reformed Italian Church at Geneva.” He further quoted from Dr. Desanctis’ book “‘My Jesuit Confessor,’” says Dr. Desanctis, “was Secretary to the French Father Assistant [of the Jesuit Order], and as he esteemed me much, and accounted me an affiliated member of the Society, he made many disclosures to me.” Amongst these disclosures were the following:—“Despite all the persecution they [the Jesuits] have met with, they have not abandoned England, where there is a greater number of Jesuits than in Italy; that there are Jesuits in all classes of Society; in Parliament; *among the English clergy*; among the Protestant laity, even in the higher stations. I could not comprehend how a Jesuit could be a Protestant priest, or how a Protestant priest could be a Jesuit, but my Confessor silenced my scruples by telling me, *omnia munda mundis*, and that St. Paul became a Jew that he might save the Jews; it was no wonder, therefore, if a Jesuit should feign himself a Protestant, for a conversion of Protestants.”¹⁵

Infiltration techniques

The extent to which the Jesuits had infiltrated society at that time was great, even though England was still a staunch Protestant Nation. To recognise this now, one only has to look in his local library or university. According to the French writer Adolphe Michel, at the end of the eighteenth century, Voltaire estimated the number of books written about the Jesuits over the years to be around six thousand. In theological colleges and public libraries, it is now hard to find any history of the Jesuits beyond the beginning of the 17th century. And carrying on with the tradition, once they became established organisations, the BBC, newspapers, and local radio were also infiltrated accordingly. (More can be learned from books such as *Jesuit Plots from Elizabethan to Modern Times*, sold by the Protestant Truth Society.)

The Jesuit infiltration of Great Britain can be summed up as follows:

“And now in anticipation of its realisation, England has been dedicated to the Madonna, and

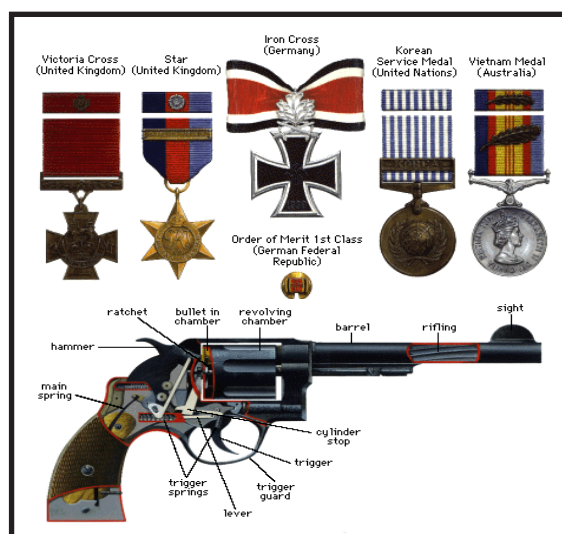
it has been christened “Our Lady’s Dowry”; and a Jesuit association of lay members, male and female, exists for the express purpose of making over the gift. This association is called the *Sodality of the Children of Mary*, and it has guilds in scores of places throughout Great Britain, each presided over by a local priest. All of these guilds are working in concert for this common end. The securing of England as “Our Lady’s Dowry” sounds somewhat poetical and harmless; but translated into plain language it means part of the carrying out of the scheme of the Conquest of England, so as to place it once more under the iron heel of the Church.”¹⁶

Schoolboys and Guns

It is obvious that Papal Rome is preparing for a spiritual war of great magnitude. And it is only with a heart surrendered to Christ that we can meet the blow that is about to fall upon Europe. For in the secret recesses, Rome is gathering its forces to re-establish the Inquisition. As we approach this new millennium she will use modern technology to her full advantage, to gather information to track down her enemies, and exterminate all that do not comply with her religious dogmas. One of Rome’s policies is to be the educators of the educators, and the leaders of the leaders. By this code she intends, not only to control Europe, but the whole wide-world. In a recent school prospectus that was issued by Stonyhurst, the Jesuits’ oldest school in England, the military training given to the students is described, for those who are to be the educators of the educators, and the leaders of the leaders:

“The Stonyhurst Cadet Corps is one of the oldest and most respected contingents in the country. The broad function of the Corps is to develop, through regular and varied training, the qualities of self-discipline, self-reliance, perseverance and leadership. All boys join the Corps in their second year and thereafter its voluntary, although demand exceeds the places available. Cadets are assigned to one of the seven platoons named after the seven Old Boys of Stonyhurst who won the Victoria Cross. Training takes place every Thursday afternoon during term; in addition there are regular weekend visits to local shooting ranges. The contingent prides itself on its shooting record,

both at smallbore and fullbore.” This form of education when put into practice will be a fundamental tool in moulding the minds of young people: “Ignatius understood more clearly than any other leader of men who preceded him that the best way to raise a man to a certain ideal is to become master of his imagination. We “imbue into him spiritual forces which he would find very difficult to eliminate later”, forces more lasting than all the best principles and doctrines; these forces can come up again to the surface, sometimes after years of not even mentioning them, and become so imperative that the will finds itself unable to oppose any obstacle, and has to follow their irresistible impulse.”¹⁷ This is subliminal warfare (mind science), educating the children to learn something that they could use at a later date for a destructive end, and maybe to be used for the furtherance of the churches goal - this goal being the re-establishment of the Holy Roman Empire, which will culminate in a single European superstate.

THE STRATEGICAL MENDACITY OF THE NEW HOLY ROMAN EMPIRE

In our previous issues we have dealt with what we call the Vatican Grand Master Plan. This plan is to erect a Roman Catholic super-state in the industrial heart of Europe. It will be patterned on the old medieval model that existed before the Protestant Reformation, where the state was in partnership with the church, and all facets of life were regulated according to church policy. A few years ago, when the present authors first heard of this Papal ambition to control the world, they were astonished that a religious institution could have such aims. But two thousand years ago on the Isles of Patmos, the apostle John was shown the final scenes of international history.

A fulfilment of Bible prophecy

In the book of Revelation is depicted a graphic description of the grand finale between truth and error. John sees the woman riding the scarlet coloured beast. A woman in Bible prophecy is a church (see **Jeremiah 6:2**) and a beast in symbolic language typifies a political kingdom (see **Dan 7:23**). So it is evident that this corrupt church is to dominate the dual power of authority prior to the second coming of Jesus Christ. Before we attempt to enlarge on this colossal attempt of the world's most fiercest religion, it would be good if we would give a historical breakdown of the momentous events of this century. We will also look at how Rome has forged relationships with war like nations.

THE GERMAN NATION AND THE PAPACY

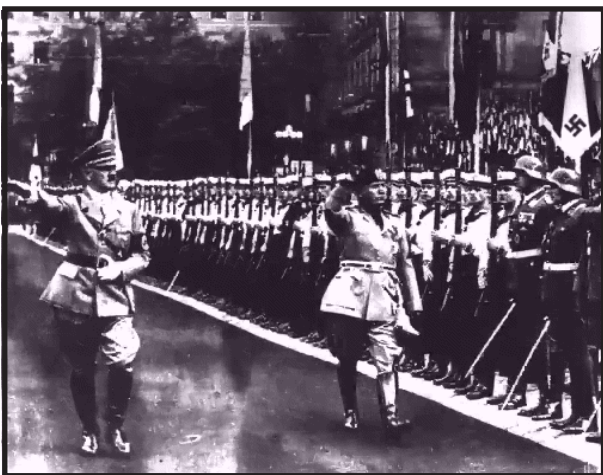


In the year 782 Charlemagne, the King of the Franks, became the military champion of the Papacy. Pope Leo III crowned Charlemagne emperor in Notra Dame cathedral in 800 A.D. The future of Europe was bound up in this event, and co-operation with the Vatican and Germany has held ever since. The Reformation was viewed as a setback to this alliance, but the control of central Europe was held together by the agency of the Austro-Hungary empire. The Habsburg family acted as the paramount protectors of the Roman Catholic Church. At the beginning of this century a very significant factor came to light, which was to ever shape the future of our modern world.

L. H. Lehmann in his book *Behind The Dictators*, explains it thus “For centuries Vatican policy has based all its hopes for the restoration of its dominion over the nations of Europe upon a strong, militaristic Germany that would cleanse the continent of all British Protestant influence from the west, and above all, safeguard it from Russo-Slavic invasion from the East.”¹ Pope Leo XIII actually urged this very plan on Kaiser Wilhelm II of Germany. *The following are the Kaiser’s own words:* “It was of interest to me that the Pope said to me on this ... that GERMANY must become the sword of the Catholic Church. I remarked that the old Roman Empire of the German nation no longer existed, and that conditions had changed. But he stuck to his words.”² The slaughter that took place during the first World War was a result of this far-reaching master plan of Rome. It was a vehicle to implement Catholic hegemony in Europe.

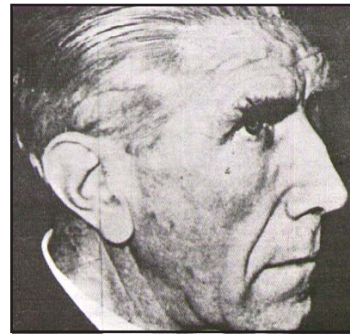
Catholicism and Fascism

Another instance in this drive to create a super-state can be seen in the rise of national socialism-fascism. During the 1920's it was believed that the principles of democracy was a destructive element to the Church of Rome. The papacy was convinced that absolute leaders would bring the state in harmony with the church. And it was in this climate that Adolf Hitler was to arise to power. He was swept into office thanks to the Roman Catholic Church. "The Fuhrer had come to power, thanks to the votes of the Catholic Zentrum, ... but most of the objectives cynically revealed in "Mein Kampf" were already realised; this book an insolent challenge to the western democracies, was written by the Jesuit Father Staempfle and signed by Hitler."³

It is important for the reader to note that the **Second World War was stage two of the plan to unify the European continent.** Soon after Hitler came to power, Catholic Franz Von Papen, German politician, and Privy Chamberlain to the Pope said "The Third Reich is the first power in the world, not only to recognize, but also to put into practise, the high principles of the Papacy."⁴ *That high principle being the Inquisition, or simply put, the destruction of anyone or group that steps out of line with the church-state / empire.* Thanks to the providence of an all powerful God this attempt was foiled, but at a great cost and loss of human life.

CONQUEST BY TREATY'S

This century that is about to come to a climatic end, has been plagued with wars, bloodshed and strife. The people of this continent have had enough of armed confrontations. So after the Second World War, attempts were made to end all threats of international disputes. It was to be the dawn of what we now call the peace process. All the tensions that occurred around the core of central Europe had come to an end. The only threat of war was between the U.S.S.R led Warsaw Pact, and the U.S.A. led N.A.T.O. It was to be East against West. The cold war, as it was called, came to an end due to the Vatican / and covert C.I.A. operations. This was brought about with the Jesuits working with the C.I.A. based S.M.O.M. (The Knights of Malta) [*this was covered in the Voice from the Wilderness Vol. 1, No 1. The Knights of Malta are one of the oldest orders of Freemasonry, and they are controlled by the Church of Rome. They are very powerful and are also official observers at the U.N.*].

Robert Schuman, champion of Europe?

One of the first significant moves to bring peace to the continent of Europe was established by Robert Schuman, the post-war champion of a united Europe. He was ... born in Luxembourg and was an ardent Roman Catholic. He is now being considered by the Church of Rome as a candidate for sainthood.⁵ It was Robert Schuman, who was the architect of the TREATY OF PARIS in 1951, which brought into being the European Coal and Steel Community (ECSC). The purpose of this treaty was to bring

the economies of FRANCE and GERMANY together. The mergence of iron, coal, and steel, soon was enlarged to incorporate Italy, Belgium, the Netherlands and Luxembourg. Vatican insider Avro Manhattan, states in his book *Vatican Imperialism in the twentieth Century* "The real purpose of the merger was, not to increase the production of civilian goods, but to promote a colossal speed-up of war weapons ... This coal and steel merger plan, with its "much wider implications," was Catholic inspired."⁶

From Paris to Rome

What the church of Rome could not do by Nazism, she was about to do through a Euro-Superstate. Slowly but secretly the plan was to move forward under the pretence of peace and prosperity. In the year 1957 it was decided that European trade barriers, and borders were to be eroded to prepare the way for stage two of the New Order. 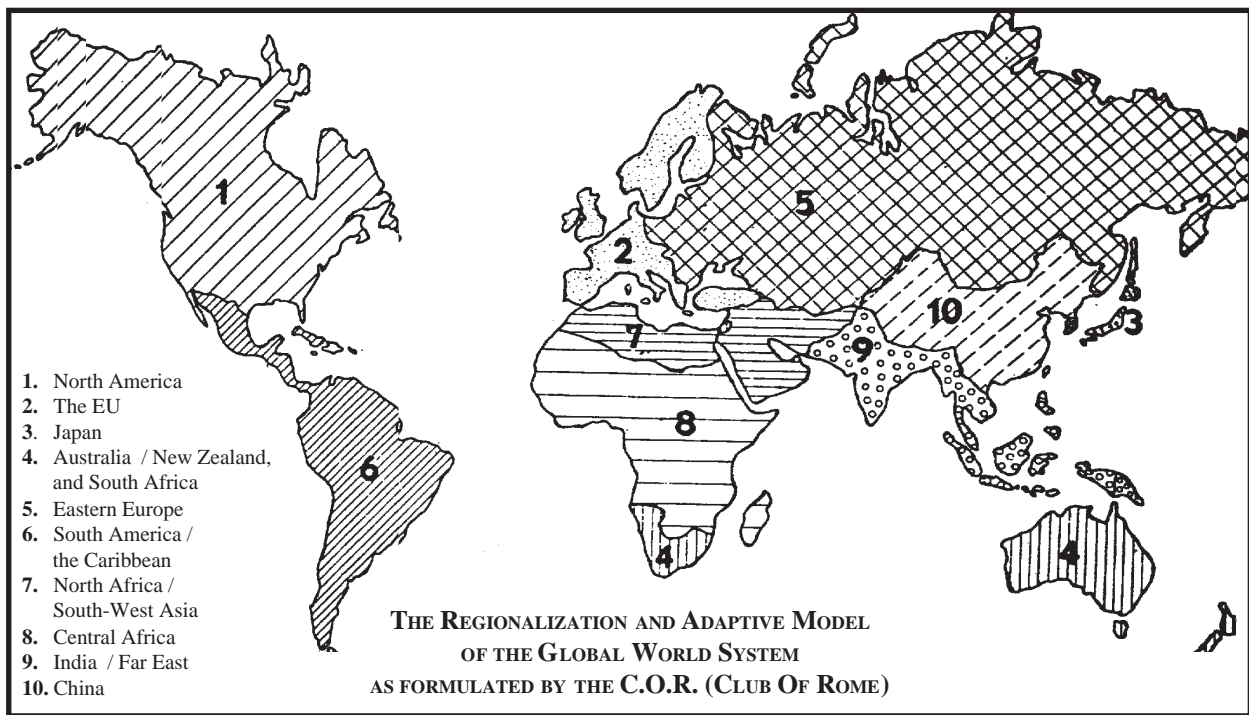

There are many students of the Bible who believe that there will never be a physical unification of this continent, and they base this view on Daniel 2:43: "but they shall not cleave one to another, even as iron is not mixed with clay." The second chapter in the book of Daniel concludes with the European question; it states that "the kingdom shall be divided" Dan 2:41. If we were to look at the book of Revelation, light would be shed on this issue of European integration, for the Bible says "And the ten horns which thou sawest are ten kings, which have received no kingdom as yet; but receive power as kings one hour with the beast. These have one mind, and shall give their power and strength unto the beast." (**Revelation 17:12-13**) It is important to note that this verse of scripture does not just deal with Europe only, for present documentation proves that it has a wider application.

Further proof of this can be found in the written works of Mrs. E. G. White. " "These have one mind." There will be a **universal (world-wide) bond of union**, one great harmony, a confederacy of Satan's forces. And shall give their power and strength unto the beast."⁸



“And the ten horns which thou sawest are ten kings, which have received no kingdom as yet; but receive power as kings one hour with the beast.” (Revelation 17:12)

““These have one mind.” There will be a universal (*world-wide*) bond of union, one great harmony, a confederacy of Satan’s forces. And shall give their power and strength to the beast.”⁸

“What we thus have is conformation of ten “kings” who will be men of vast political and economic power in the last days ... They rule over the entire earth and are of “one mind.”

It is clear then, that each one of the ten regions, (North America, The EU, Japan, Australia / New Zealand / South Africa, Eastern Europe, South America / Caribbean, North Africa / South-West Asia, Central Africa, India / the Far East and China) will have a political / economic governor, who in turn will be under the jurisdiction of the papacy; thus uniting the world *spiritually, politically and economically*.

EUROPE THE PROTOTYPE OF THE NEW WORLD ORDER

ACCORDING TO FUNK & WAGNALLS STANDARD DICTIONARY 1958:- The word prototype means “original model on which subsequent forms are to based. Or an accepted standard to which all others must conform.”¹²

We at Wilderness Publications believe that the E.U. is the model for the coming global New World Order. To understand how this will function, let us take a look at how the E.U. is emerging into a European super sovereign state. The criteria for sovereign nations are based upon these five fundamental principles:

The European Flag, symbol of the European Union and the New Holy Roman Empire

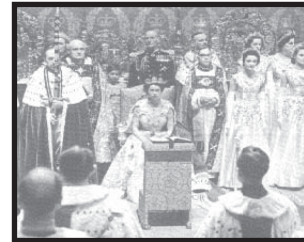
John Major by signing the first two stages of the European Economic and Monetary Union Agreement has signed over our financial sovereignty. Whether we join the single currency or not does not matter, because we now have to manage our economy not after British law, but after European law. So the second aspect of our sovereignty has gone.

Further proof of the disintegration of our sovereign rights is the fact that un-elected Eurocrats will be running our nation. "The European government machine is nothing to do with democracy and justice, and everything to do with power. ... since 1991 the Maastricht Treaty has extended the powers of the council of ministers. This in turn means that policy decisions which effect the United Kingdom are being taken by individuals who are not responsible to Britain or its electorate. For the 375 million citizens of the EU, all the decisions are taken by just 50 people: 15 heads of state and government, 15 ministers in councils in councils of ministers, and 20 European commissioners. None of these 50 has been elected by the people to carry out European government functions, and they are accountable to no-one for those functions."¹³ "The Vatican can oppose the election of certain delegates to the European Parliament on the ground that they pursue a policy contrary to that of the Church."¹⁴

Dr. D. Samuel in his book **European Union and Roman Catholic Influence In Britain**, says "What is on offer is not federalism at all, though it masquerades under that name, but an un-elected politico-bureaucracy or Euro-Fascism." So it is evident that what Hitler and the Jesuits

tried to do by war, the Roman Catholic inspired EU is doing through peace.

The British constitution and monarchy



At this critical and most decisive hour in Earth's history, God is looking for people who will not be bought or sold, people who will be true to duty as the needle is to the pole, people who are not scared to call sin by its right name. Men like the great British constitutionalist and philosopher John Locke [1632-1704] who once said concerning the role of the British government: "The government do not have any powers of itself, therefore they do not have the prerogatives or the right to give away our sovereignty and laws. Little do we know that the powers of the land are on loan to the government and parliament from the people, and that at the end of five years, or their term in office, they must be given back to the people intact, or according to how they had received it." So we can positively say what is taking place in the unification of Europe is the violation of the rights of the people of this land in which we live.

The question of sovereignty that we face as a nation is the same question that the British people faced during the Protestant Reformation. That question being, Which sovereign? **Queen Elizabeth II or Pope John Paul II?** It is either one or the other, for the Bible says "Can two walk together, except they be agreed." (Amos 3:3). It has to be remembered that the Pope is a autocratic ruler (autocracy means absolute power without restraint). But the monarch is the guarantee of civil and religious liberty, just as the First Amendment of the Constitution is the guarantee of civil and religious liberty in America. "The powers of the monarch, as described by Bagehot in the mid-nineteenth century, have been largely those which have existed up to the present time. In his book *The*

English Constitution, Walter Bagehot enumerated the three rights of the monarch under the constitution: the right to be consulted, the right to encourage, and the right to warn. He has no others. He must sign his own death warrant if sent up to him by parliament.”¹⁵

Europol, the modern Gastapo

The current trend is that soon, and very soon, because of integration into Europe, there will be no point in us having a monarchy. For we will become a province in a country called Europe, whose king would be the Pope. The consequences of this for Christians who have learned to embrace the principles and liberties that come from dwelling in a Protestant land, will be thus: “The Evangelical Alliance notes that Evangelical Christians are perceived by the EU as a ‘sect’, and that any group which does not belong to the majority church (Roman Catholic) is viewed by many MEPs with suspicion.”¹⁶

When we look at how the embryo of the European Inquisition is being formed, we realise it is just a continuation of the twentieth century plan of Adolf Hitler and Kaiser Wilhelm to have a pan Germanic-Catholic superstate. It will also have its secret police, just as Nazi Germany had its secret police: “... the Europol that Germany champions is a pan-Europe police force in which Germany sees itself as the dominant influence, if not its head. Which situation, throughout the other nations of the Union with still too recent memories of two world wars, ranges from the unpalatable to the totally unacceptable.”¹⁷

Before Rome and her agents make a strike, it is their procedure to make dossiers on her enemies and foes. She uses the secular arm to enforce and advance the principles of the Inquisition, and the coming European tribunal is already in the process, and Europol has an enormous part to play, if unification of the continent were to succeed. “David Hallam MEP has confirmed that a European resolution on sects and cults permits the European police force (Europol) to carry out surveillance on such groups’ activities. He adds: ‘In Europe, this could include Christians.’ Whereas most MEPs have said there is no threat to ‘bona fide religions’

(institutionalised churches), during the debate on this resolution, one speaker did lump Evangelicals (Bible believing Christians) in with Satanists”¹⁸

THE ULTIMATE AIM OF THE PAPACY

“And through his policy also he shall cause craft to prosper in his hand; and he shall magnify *himself* in his heart, and by peace shall destroy many:”

Daniel 8:25

Amidst all of the confusion, rush and hurry of this world, the drive towards global supremacy has been going forward secretly but unrelentlessly. **There can be no doubt that the same aim that Guy Fawkes and his co-conspirators had to destroy our Protestant throne and sovereignty, is still being pursued today.** Furthermore, the system that used Guy Fawkes in 1604, has the added advantage in 1997 of being aided by high technology and advanced communications. Though the mass populace might well believe that they are dwelling in safety, they are ignorant of the methods that Satan uses to control the conscience, and secure homage to himself:

The law of worship

The European Commission at this time are trying to get people to have one day in seven to rest. This is according to the 48-hour week working directive. The argument is that by setting a maximum of 48 hours for a working week, then it will stop people from working for excessive hours. "When the directive reaches the private sector it is likely to have the greatest effect on small businesses employing just a few staff who work long hours."²⁰

One of the main provisions of the directive is that there should be a **"Minimum of one rest day a week..."**²¹ Britain is the only country that is opposed to the 48-hour working week directive, and have been accused of holding up the European Union treaty negotiations upon this subject. But: "... the European Court of Justice decided to dismiss all of Britain's arguments in its appeal for the annulment of the 1993 working-time directive ... **The court's only concession was to annul a provision, inserted at Germany's request, that had set Sunday as a rest day in principle.**"²²

Sunday, because of Germany's position in the EU, is certain to be set as an official rest day in Europe. Instead of people resting from work voluntarily, soon they shall have to by European law. This may look to be a heaven sent blessing for Christians, but Roman Catholic literature declares: "Question -Why do we observe Sunday instead of Saturday? Answer -We observe Sunday instead of Saturday because the Catholic Church, in the Council of Laodicea, 336 A.D., transferred the solemnity from Saturday to Sunday."²³ "Sunday is a Catholic institution, and its claims to observance can only be defended on Catholic principles ..."²⁴

Sunday laws, as history testifies, have their origin with the papacy. Sunday is not the seventh day of the week, but the first, and this tradition of honouring the first day of the week runs right back to ancient Babylon, where the first of every thing was dedicated to the gods: "... the sun or the most important god receiving the first day, the moon the second day, and so on up to Saturn who received the last or seventh day of the week."²⁵ The Bible has never declared a change of rest from the original sabbath (Saturday) that God instituted

in Eden, for God Himself rested upon the seventh day: "And on the seventh day God ended his work which he had made; and he rested on the seventh day from all his work which he had made. And God blessed the seventh day, and sanctified it: because that in it he had rested from all his work which God created and made."²⁶ The scriptures declare about the words of God that: "They stand fast for ever and ever."²⁷

The origin of the word

Protestants and sincere Roman Catholics all over the world, who are ignorant of the system that they are in, need to realise that: "The word **Catholic** was formerly an astrological term (**Catholicus** was the **Latin name of the Greek god Cosmos**, who was worshipped as the universe deified who **was represented with hoof's, horns, a tail, and a pitchfork** ...
